DUTIES AND RESPONSIBILITIES

Under the overall supervision of the Assistant Director General/Regional Representative, RAP, and the functional guidance of the Director, Climate, Energy and Tenure Division, NRC, in close coordination with NRC and NRL Officers in Asia and the Pacific Region, and under the direct supervision of RAP Land Management Officer, the incumbent will provide support on land tenure in the region. In particular, the incumbent will:

- contribute to FAO's programme on land tenure and land administration and support implementation of the voluntary guidelines on responsible governance of tenure;
- monitor key developments in land tenure and land administration, and provide guidance in areas of technical specialization as appropriate;
- collaborate with member countries in the analysis and formulation of policies on land tenure and land administration;
- contribute to field programme development through the identification, formulation, implementation, backstopping and review of projects on land tenure and land administration;
- facilitate development of information products including technical and policy reports, guidelines and manuals for land tenure and land administration;
- coordinate and participate in technical meetings and workshops for assisting the transfer of knowledge and information on land tenure and land administration;
- prepare clear and concise reports on land tenure and land administration;
- collaborate in a multidisciplinary team in work on voluntary guidelines of the responsible governance of tenure;
- perform other related duties as required.

MINIMUM REQUIREMENTS

Candidates should meet the following:

- Advanced university degree in land tenure, land administration or related fields
- One year of relevant experience in land tenure and land administration, including experience in developing countries and/or countries in transition
- Working knowledge of English, French or Spanish and limited knowledge of one of the other two or Arabic, Chinese or Russian

Candidates will be assessed against the following:

- Relevance of experience in land tenure and land administration and their governance with particular emphasis on developing countries and countries in transition
- Ability to plan and organize own work, deliver results and meet deadlines

- Excellent oral and written communication skills
