# **Organizational Setting**

**ORGANIZATIONAL UNIT:** 

The Office of the Legal Counsel ensures that the Organization's activities are carried out in accordance with its Constitution and the other Basic Texts of the Organization, in a manner consistent with its status as an inter-governmental organization of the United Nations system, and that its relationships with governments, organizations and individuals are on a sound legal basis.

The position is located in the Development Law Branch (LEGN) of the Legal Office. LEGN provides legal advisory services to governments on food and agriculture and natural resources (including land, water, fisheries and aquaculture, plants, animals, food, forestry, wildlife and environment and biodiversity), as well as general agricultural issues (institutions, trade, economic reform).

The successful candidate will be outposted and based in one of the Organization's regional or sub-regional offices, the location of which is to be determined by the Organization. The appointment will be at either the P-3 or P-4 grade. The Organization reserves the right to determine the grade, taking into account the functions of the post, and the qualifications and experience of the successful candidate. It also reserves the right to make an appointment with a modified job description.

#### **Reporting Lines**

The Legal Officer reports to the Senior Legal Officer, LEGN, and is under the overall guidance of the Legal Counsel.

#### **Technical Focus**

Development Law, including legal and institutional matters pertaining to the Organization's activities and mandate in relation to food and agriculture and management of renewable natural resources.

## **Key Results**

The provision of comprehensive legal support for the planning and delivery of multi-disciplinary legal-related activities, services and advice on questions pertaining to the Organization's mandate, in support to the FAO Strategic Programmes and related Delivery Mechanisms.

### **Key Functions**

- Reviews a wide range of multidisciplinary and complex legal matters involving issues of international, public, private, and development law, including interpretation and application of instruments (both substantive and procedural);
- Provides legal advice to the Members Countries, FAO Technical Units at Headquarters and Decentralised Offices on the legal and institutional aspects of the governance and management of sustainable agriculture and natural resources, involving diverse substantive and procedural questions of considerable complexity which may call for the development of new legal modalities to meet unique needs/circumstances;
- Coordinates with and contributes to the work of relevant Strategic Programmes, Technical Units at FAO Headquarters and Decentralised Offices in order to ensure best synergies between legal, policy and governance related work in support of Member Countries:
- Reviews legal frameworks and prepares recommended texts of laws, regulations and other legal instruments, performs
  extensive legal research and analysis, and advises on and drafts legal opinions, briefs, reports, correspondence, as well
  as studies, publications, agreements, international instruments and other legal documents:
- Contributes to the preparation and implementation of field projects, including the conduct of advisory missions and the selection/supervision of consultants, particularly in the region to which the position is assigned;
- Responds to requests for information on national and international law relating to agriculture and the management and development of natural resources;
- Contributes to the implementation of FAO's gender policy including through the above-mentioned areas of work;
- Serves on various standing boards, committees, ad hoc working groups and task forces, as required;
- Promotes the work of LEGN and represents the Organization in meetings, conferences, seminars, etc.
