## **National Consultant - Biosecurity Expert**

### **General Responsibilities**:

Under the overall supervision of the FAO Representative in Bangladesh and under the guidance of the FAO Chief Veterinary Officer (CVO), the general technical supervision of the Emergency Centre for Transboundary Animal Diseases (ECTAD) Regional Manager based in the Regional Office for Asia and the Pacific (RAP), the National Consultant - Biosecurity Expert will be under the direct technical supervision of the Chief Technical Advisor (CTA) of FAO – Technical Unit (FAO-TU) within the Department of Livestock Services (DLS). The The incumbent will be responsible for:

- Assist in preparation and revision of detailed work plans in all biosecurity-related works;
- Establish and maintain a working relationships with DLS staff, staff of the various market committees and the
  Dhaka City Corporation, and with personnel on the LBM C&D teams so as to facilitate the introduction of
  enhanced C&D procedures to designated LBMs;
- Assist with the C&D training of LBM cleaning and disinfecting personnel;
- Identify the equipment, input and infrastructure needs for the targeted LBMs and ensure the initial stocks are replenished as necessary;
- Assist in the supervision of contracts for the supply of inputs and minor infrastructural improvements to LBMs;
- Assist where necessary with the market-information gathering and market surveys;
- Oversee the C&D procedures prescribed for each of the assigned markets, and ensure the cleaning supervisors and teams utilise the issued equipment and inputs so as to perform their tasks in accordance with the SOPs;
- Identify defects or limitations in the SOPs and identify constraints encountered with the implementing of C&D procedures in the LBMs;
- Assess biosecurity in commercial farms and backyards affected with HPAI;
- Identify needs for improving biosecurity in commercial farms and backyards;
- Prepare and submit regular implementation reports and assist the National Project Manager in preparing quarterly, mid-term, and final reports;
- Other duties as required by CTA

#### **Required Competencies:**

The Consultant will be a veterinarian with good communication skills and several years of experience in the poultry sector in Bangladesh. Experience with the management of small teams, and demonstrated first-hand experience in relevant field will favourably be considered. Proficiency in both written and spoken in English is essential
