7) Building resilience in the region through agrifood systems transformation and the use of early-warning systems

Discusses the need for systems and integrated approaches to resilience to be strengthened in order to address the multiple risks and vulnerabilities that affect agrifood systems in the region.

II. Programme and Budget Matters

8) Results for FAO in the region 2022-2023

This session presents and analyses the main results achieved by FAO in Latin America and the Caribbean during the 2022-2023 biennium. The 37th Session of the FAO Regional Conference for Latin America and the Caribbean (LARC 37) requested the Organization to localize the FAO Strategic Framework 2022-31 in the specific conditions, needs and priorities of the Members in the region and to deliver in two complementary fronts: (i) in the short-term, by supporting country-level recovery efforts to overcome the economic and social impacts caused by the COVID-19 pandemic in the food and agriculture sector; and (ii) in the medium to long term, by supporting countries to transform agrifood systems in accordance with national contexts, priorities and capacities.

FAO addressed the recommendations, achieving significant results in: (i) supporting measures and investments aimed at ensuring physical and economic access to safe and nutritious foods to achieve healthy diets, and supporting policies and programmes to reduce malnutrition; (ii) promoting rural economic activities to build productive, innovative, and inclusive rural societies accompanied by social inclusion policies, focusing on eradicating extreme poverty and ending hunger; and (iii) building sustainable and resilient agrifood systems and supporting Members in accessing environmental and climate financing to overcome the challenges in the rural sector.

9) Priorities for FAO in the region under the FAO Strategic Framework 2022–31

This session focuses on discussing FAO's programmatic focus for the biennium 2024-2025 and beyond under the FAO Strategic Framework 2022–31. The proposed priorities are informed by the aforementioned Strategic Framework 2022-31, Medium Term Plan (Reviewed) 2022-25 and the Country Programming Frameworks (CPFs) to support countries to achieve MORE efficient, inclusive, resilient and sustainable agrifood systems, for *better production*, *better nutrition*, a *better environment* and a *better life*, leaving no one behind.

The conclusions and recommendations of the Regional Commissions in Latin America and the Caribbean will be assessed with regards to: (i) policy and regulatory matters; and (ii) programme and budgetary matters. The Regional Commissions include the Latin America and Caribbean Forestry Commission (LACFC), the Commission on Livestock Development for Latin America and the Caribbean (CLDLAC), the Commission for Small-Scale and Artisanal Fisheries and Aquaculture of Latin America and the Caribbean (COPPESAALC), the Western Central Atlantic Fishery Commission (WECAFC) and the FAO-OEA/CIE-IICA Working Group on Agricultural and Livestock Statistics for Latin America and the Caribbean.
