REPORT OF THE HUNDRED AND FORTY-FIFTH SESSION OF THE FINANCE COMMITTEE

1 June 2012

HR Strategic Framework and Action Plan 2012-13

7. In considering the HR Strategic Framework and Action Plan for 2012-13, the Finance Committee noted the substantial achievements which had been attained through the 2010-11 HR strategic framework in delivering key initiatives, including *inter alia* the formulation of a competency framework, launch of a performance management system as well as the institution of the HR strategy, communication and career development functions.

8. The Committee:

• <u>underscored</u> in particular the importance of the performance management system and its linkage to an effective career development process, as well as of pursuing the implementation of a competency framework within the established timeframes.

- <u>emphasised</u> the need to promote a more systemic training and continuous learning programme aimed at enhancing the skills and competencies of all staff and the leadership capabilities of the management cadre.
- <u>reiterated</u> the need to promote a merit-based selection process which secures equitable geographic representation and gender balance amongst the workforce and <u>stressed</u> that recruitment should be completed within the shortest timeframe. In this context, the Committee also <u>requested</u> further information as to the process and rationale for the adoption of a revised approach on calculating the geographic representation.
- 9. As for the proposed restructuring of the HR management function into two separate entities (an Office for Human Resources in the Apex and an HR Support Service in the CS Department), the Committee **requested** further information and clarification on the proposed revision of the HR function before taking a position. It **requested** in particular to receive the note from the Legal Counsel relating to the authority of the Council to make a decision on structural adjustments, in order to facilitate further consideration of the proposal.

10. The Committee was informed that the 146th Session was scheduled to be held in Rome from 8 to 12 October 2012.
