Agenda 2030

- The United Nations, after the expiration of the Millennium Development Goals, established a new global development agenda, Agenda 2030 in September 2015.
- Agenda is based on three main pillars: eradicate poverty, protect the planet and ensure prosperity for all.
- The agenda includes 17 sustainable development goals COR (SDG -Sustainable Development Goals), 169 targets and contains 232/244/247/248 indicators and should be realized in the next 15 years.
- The basic motto of Agenda 2030 can be reduced to the sentence leave no one behind (LNOB), that no one is left behind!





Agenda 2030 in the Republic of Serbia

- Global, UN indicators of the Sustainable Development Goals (145 out of 248 indicators - 58%): SORS databases
- EU indicators of Sustainable Development Goals (61 out of 101 indicators 60%): Eurostat database





Agenda 2030 in the SORS (1)


- At the end of 2017, a SDG Working Group (WG) was established in the Statistical Office of the Republic of Serbia (SORS) to monitor 17 sustainable development goals.
- The WG has 15 members and each member is in charge of one or two goals.
- The task of the member is to monitor the goal for which he is in charge, to update data and introduce new indicators, to monitor changes in methodology and to participate in domestic and international correspondence.





Agenda 2030 in the SORS (2)

- The goal is to increase the number of UN SDG indicators for the Republic of Serbia
- The SDG reporting is in the quarterly and annual dynamics
- 43 indicators November 2017
- 145 indicators April 2024







Goal 5 (1)

- Goal 5 contains 14 UN SDG indicators, 12 indicators are provided for the Republic of Serbia and they are on the SORS web portal.
- They make 86% of the required indicators of the Goal 5.
- These are as follows: 5.1.1, 5.2.1, 5.2.2, 5.3.1, 5.4.1, 5.5.1, 5.5.2, 5.6.1, 5.6.2, 5.a.2, 5.b.1 и 5.c.1.
- Two indicators are missing. When it comes to the indicator 5.a.1, for the Republic of Serbia, the indicator will be available in 202*.
- When it comes to the indicator 5.3.2, data will probably not be collected because there are indications that the occurrence of genital mutilation does not exist in the Republic of Serbia or is very small.





Goal 5 (2)

- Goal 5.
- Achieve gender equality and empower all women and girls
- Target 5.a
- Undertake reforms to give women equal rights to economic resources, as well as access to ownership and control over land and other forms of property, financial services, inheritance and natural resources, in accordance with national laws
- Indicator 5.a.1
- (a) Proportion of total agricultural population with ownership or secure rights over agricultural land, by sex; and
- (b) share of women among owners or rights-bearers of agricultural land, by type of tenure

- Developed module for data collection
- Fieldwork
- Conclusions and future steps







Indicator 5.a.1 (2)

- In the Republic of Serbia, there is no data on the indicator SDG 5.a.1, which aims to measure the extent to which women are in a disadvantageous position in terms of ownership and securing the right of ownership of agricultural land
- Taking into account the sample size and the burden of correspondents, the Survey on the structure of agricultural holdings (FSS 2018) was identified as the best source of data for the assessment of SDG indicator 5.a.1
- SORS developed a data collection module for SDG indicator 5.a.1 and corresponding survey instruments, following the FAO methodology, and created an action plan for regular data collection and reporting on SDG indicator 5.a.1 for the next period





Indicator 5.a.1 (3)

Separate (pilot) statistical survey

- A questionnaire and Instructions for interviewers were created that related to an additional set of questions for collecting data on ownership or secure rights on agricultural land (Q8-Q12)
- In addition to these questions, the survey contained seven questions (Q1–Q7) that were already an integral part of the Survey on the structure of agricultural holdings (FSS)





Indicator 5.a.1 (4)

- Testing (field work) of the developed tools was carried out on a selected number of agricultural households (20 households) – September 2023
- Reference population: Holding members (aged 18+) that practiced agricultural activity in 2022/2023. Relatives that practiced agricultural activity and other regularly employed persons on the holding who are not family members were excluded

Field work (8)

- Pilot survey was successfully conducted across 20 households and 71 household members were interviewed
- Data collection method: Face to face interview, paper questionaire
- Respondent approach and coverage: Household head or most knowledgeable household member is interviewed to collect information on all the household members aged 18 and above
- Field work: 5 days
- Data entry (excel base): 1 day







Conclusions and Future steps (1)

- Cooperation with the households was very good. Response rate was 100% and all questions were answered. Questions are perceived as easy to answer
- Feedback from the testing phase helped us to finalize the survey module tools, specifically the Instruction manual for the interviewers. (We specified that joint ownership/secure rights on agricultural land do not have to be with a member of the household only)







Conclusions and Future steps (2)

- The Roadmap is developed for implementation of the survey including the calculation of the indicator
- Tested module for calculation of the indicator 5.a.1 will be included in the next round of the IFS (Integrated farm survey) in 2026, following the developed Roadmap which covers activities required for implementation of this module and responsible institution for each activity
