- 1. Title:** Food Systems Transformation as an Accelerator for the Agenda 2030 and AU 2063 Agenda Implementation in Africa: Lessons and Insights from the frontline
 - 2. Introduction:** Alongside the ARFSD-10, the UN FS Coordination Hub is organizing a series of platform meetings primarily bringing together National Convenors to network and share experiences and insights on food systems transformation efforts in their countries. These include the main National Convenors Meeting scheduled for the 22nd April 2024. This note is specifically on the pre-Main Meeting session scheduled for the 17th April 2024. Unlike the Main Meeting, which is physical, this pre-Session will be held virtually.
 - 3. Brief background:** The UN Food Systems Summit +2 Stocktaking Moment (UNFSS+2) in 2023 marked a pivotal juncture, offering a unique opportunity to harness the potential of sustainable, inclusive, nutritious, and resilient food systems as driving forces towards Agenda 2030 goals.

Recognizing the transformative power of food systems, the 2023 Global Sustainable Development Report underscores the critical role food systems play in fostering sustainability across human, the environment, social and economic realms. This perspective is echoed in the Africa Common Position on Food Systems, a synthesis priorities and ambitions of Member States. A key takeaway from the UNFSS+2 Special Event on Building Africa's Food Sovereignty and Resilience through Sustainable Investments is the need to support the African Common Position on Food Systems with catalytic policy options and strategies, and sufficient financing to enable the game-changing solutions identified.

In November 2023, the UN Food Systems Coordination Hub, in collaboration with the 4SD Foundation, organized five regional touchpoints to introduce the Food Systems and Climate Action Convergence Initiative to National Convenors. The insights gathered from the National Convenors during the touchpoints emphasized the importance of aligning food systems transformation with climate action to achieve the Sustainable Development Goals (SDGs). They outlined ongoing efforts to link these agendas and welcomed the Convergence Initiative for its potential to contribute significantly at both national and regional levels, while adapting to the diverse contexts of each country. Participants also recognized its ability to foster cooperation and synergy among diverse stakeholders operating at various scales including farmers and other frontline practitioners.

4. Session objective:

The Session aims to provide National convenors an opportunity to draw insights and continued motivation from both national and regional advances on food systems transformation, connecting to strides being made in the implementation along the national FS pathways and climate action.

The Session is also expected to contribute to country-level (i.e. National Convenors) input to the overall ARFSD-10 Outcome Report, thereby contributing to global and regional momentum on food systems transformation.

Specifically, the Session will:

- discern the key actions required at both national and regional levels to effect transformative changes in food systems
- explore issues of alignment with climate action, fostering resilience while enhancing food security.

The Session will strategically build upon the conclusions drawn from global processes such as UNFSS+2 STM, the SDGs Summit, and COP28, while also leveraging insights from regional frameworks such as CAADP, the Malabo Declaration, and the African Union Common Position on Food Systems.

5. Proposed format of session:

The Session is organized as a Conversation; offering national convenors opportunity and space to share and network among themselves as well as with leading players in the Ecosystem of support

6. Key SDG(s) to be addressed in the proposed session:

SDG1 (No Poverty), SDG 2 (Zero Hunger), SDG 13 (Climate), SDG16 (Strengthening institutions) and SDG 17 (Partnerships);

7. Contribution to the theme of the ARFSD-10 forum – what transformative solution(s) will be presented?

- **Addressing food insecurity**, and hence achievement of SDG2, through focusing on challenges and game changers for accelerating food systems transformation. Food system transformation would contribute to strengthening the resilience capacity and enhancing nutritional outcomes in line with global and national commitments.
- **Addressing the Food-Climate nexus:** Harness the potential of the Hub Food and Climate Convergence Initiative in supporting UN member states to align food systems' national pathways to each of Nationally Determined Contributions (NDCs), and National Adaptation Plans (NAPs).

8. Key topics/questions to be addressed by the session:

- Highlight key factors, megatrends and opportunities impacting local food systems transformation
- What are the best practices and tools that governments and stakeholders can tap into to accelerate food systems transformation?
- What policy options, actions, and mechanisms that could foster synergies between food systems and climate action?
- What are, within local circumstances and contexts, key success factors for food systems transformation alignment with NDCs & NAPs?

9. Which stakeholder groups will be included in the session? (youth groups, CSOs, etc.):

- Youth, and CSOs
- Private Sector
- International Finance Institutions

10. Will this session relate to any regional or global processes/summits?

- Follow-up to 2023 – SDG Summit, COP28, UN Food Systems Summit Stocktaking Moment, Africa Climate Summit and AU Post-Malabo CAADP processes.
- Preparation for 2024 – Summit of the Future, UN Regional Forums, CBD COP 16, UNCCD COP 16, COP29 and beyond, Nutrition for Growth Summit.
