

Twenty-third virtual meeting 22-26 July 2024

Codex strategic plan 2020-2025: implementation in the Latin America and Caribbean region

(Document prepared by the CCLAC Chair and Secretariat)

## INTRODUCTION AND BACKGROUND

- 1. At its forty-second meeting¹ (CAC42, 2019), the Codex Alimentarius Commission (CAC) adopted the "Codex Strategic Plan 2020-2025" and annual implementation reports that had been submitted at meetings of the Commission Executive Committee (CCEXEC) since that time. The Codex Secretariat, FAO and WHO support these organizations in attaching high priority to food safety and quality and guide the CAC in carrying out its responsibilities and its unique mandate to protect the health of consumers and ensure fair practices in the food trade. It reported to Members, international intergovernmental and non-governmental organizations and other stakeholders on how the CAC intends to fulfil its statutory purpose and meet the needs of Member States during the period 2020-2025, as well as on emerging issues and expectations.
- 2. The Strategic Plan lists five goals which are detailed below. These include addressing current, emerging and critical issues in a timely manner for the development of standards based on science and Codex risk analysis principles and increasing their impact through the use of Codex standards. This means encouraging all Codex Member States to take part throughout the standard-setting process and improving work management systems and practices that support the efficient and effective achievement of all the strategic plan objectives.
- 3. The region reviews Codex Strategic Plan 2020-2025 implementation every two years during the CCLAC meeting, which provides an opportunity to review and fine-tune the Plan based on results achieved, current circumstances and other relevant factors.

# REVIEW OF IMPLEMENTATION OF CODEX STRATEGIC PLAN 2020-2025 ACTIVITIES FOR THE LATIN AMERICA AND CARIBBEAN REGION

- 4. During the twenty-second meeting of the FAO/WHO Coordinating Committee for Latin America and the Caribbean (CCLAC22), it was not possible to discuss agenda item 7 "Implementation of the Codex Strategic Plan 2020-2025" due to lack of time, so it was agreed to establish an Electronic Working Group (EWG) that would work in Spanish and English, under the leadership of Ecuador as Coordinator of the CCLAC, in which members and observers from the region could participate, with the following terms of reference:
  - i. review and update the Regional Workplan 2022-2024 to support the implementation of the Codex Strategic Plan 2020-2025;
  - ii. review and update the Regional Communications Workplan 2022-2024;
  - iii. finalize the update of the workplans within six months in order to facilitate their implementation before the twenty-third CCLAC meeting.
- 5. Through this EWG, the activities to be carried out in the CCLAC region from 2022 to 2024 to support the implementation of the Codex Strategic Plan 2020-2025 were agreed and are set out in the workplan (**Appendix I**). Activities planned in the region for Strategic Plan implementation met significant challenges,

mainly because most Codex Committees had gone back to holding in-person meetings. The information from the EWG report is set out in **Appendix III**.

- 6. In order to evaluate implementation of the Codex Strategic Plan 2020-2025, the CCLAC Coordination organized the "Regional Workshop for the popularization of Codex Alimentarius work in CCLAC countries 2020-2024", on 19, 20, 21, 26, 27 and 28 February 2024, in which 31<sup>2</sup> countries from the region participated. The activities are set out in **Appendix I**.
- 7. During the Workshop, Member States were asked to focus mainly on the following points:
  - setting up of a National Committee (if no National Committee has been set up, outline the way the Codex Secretariat operates in your country).
  - your physical, virtual or hybrid participation in Committee meetings held in the period 2022-2024.
  - your participation in Electronic Working Groups.
  - events held.
  - general activities carried out in relation to Strategic Plan goals.
  - general activities carried out in relation to Strategic Plan objectives.
  - general recommendations and considerations.
- 8. Information gathered through the above workshop for each goal is set out below.

# Goal 1: "Address current, emerging and critical issues in a timely manner"

- 9. Several Codex General Subject Committees and Commodity Committees discussed the prioritization criteria they used to guide their work, so CCLAC applied similar approaches when considering principles for establishing prioritization criteria. The following factors were considered:
  - the statutory purpose of the Codex Alimentarius, as well as the mandate of the FAO/WHO FAO/WHO
    Coordinating Committees and thus the adoption of standards with the dual purpose of protecting
    consumer health and establishing fair practices in world food trade.
  - contribution to the achievement of the United Nations Sustainable Development Goals (SDGs) and its influence on the food security and food safety scenario in the region. The SDGs involved are:
  - SDG 2: Zero Hunger;
  - SDG 3: Health and well-being;
  - SDG 12: Sustainable production and consumption:
  - SDG 17: Partnerships for the goals
  - forming partnerships and raising awareness among stakeholders to prioritize needs.

## Goal 2: "Develop standards based on science and Codex risk analysis principles"

- 10. The region supports the statutory purpose of Codex, and therefore upholds the principle of science-based decision-making when adopting Codex Alimentarius standards, guidelines and codes of practice. To this end, it has succeeded in strengthening capacities at the national and delegate levels.
- 11. The efficient running of National Codex Committees and Codex Contact Points (CCPs) is being strengthened through initiatives sponsored by international organizations such as FAO, WHO, the FAO/WHO Codex Trust Fund (CTF), the Codex Programme for the Americas of the Inter-American Institute for Cooperation on Agriculture (IICA), and the International Regional Organization for Plant and Animal Health (OIRSA), among others. Some of the initiatives are listed below:
  - 1. The in-person event "Food Safety Risk Management decisions based on scientific evidence. Establishing maximum levels for chemical contaminants in food (MLs)."
  - 2. The virtual seminar "Analytical Measurement Uncertainty in the Codex Alimentarius."

3. A virtual training on the use of the Global Environment Monitoring System / Food Contamination Monitoring and Assessment Programme (GEMS/Food) database in virtual format.

12. Member States agree that the provision of science-based data lies at the heart of the standards, relying on scientific advice provided by Codex subsidiary bodies (JECFA, JEMRU, JMPR, JUMNU). However, this is one of the main challenges in the region due to limited resources for data generation.

#### Goal 3: "Increase impact through the recognition and use of Codex standards"

- 13. CCLAC Member State CCPs maintain a continuous presence in various committees, depending on the priorities of each country, in order to make use of Codex standards, guidelines and codes of practice. Member States use the same participatory approach to promote the use of Codex standards at the national level in various places: governments, chambers of commerce, food quality assessment institutes, universities, industry, consumer service institutions, scientific and public institutions, etc.
- 14. The Latin American and Caribbean region is a well-known global breadbasket<sup>3</sup>, with great export prowess. It is also a food importer, and we recognize that the use of Codex standards leads to safer and more transparent international trade.
- 15. One of the main mechanisms for popularizing Codex standards has been the organization of workshops, training activities and events in all formats (in-person, virtual and hybrid). These include celebrating World Food Safety Day (WFSD) every year with the aim of increasing knowledge and awareness of Codex among public, private and academic stakeholders (policymakers, the media, the food supply chain, consumers, etc.). In 2023, we marked the sixtieth anniversary of Codex, and events were focused on highlighting this event.
- 16. Communication between National Committees and stakeholders at the national level has helped greatly in developing awareness-raising activities and celebrating achievements. One of the main events in this biennium was the celebration of Codex's sixtieth anniversary. Member States used the "Regional Workshop for the popularization of Codex Alimentarius work in CCLAC countries 2022-2024" to showcase activities carried out. These included: training, workshops, talks with stakeholders at all levels, recreational activities for better learning and sporting activities involving civil society in general.
- 17. The CCLAC coordination used the above resources to organize 17 events, from September 2022 to May 2024, with the participation of more than 8,600 delegates from the region (public, private and academic sectors), virtually and in-person, with simultaneous interpretation into Spanish, French (from the beginning of 2022) and English. It was supported by FAO, WHO, PAHO/PANAFTOSA, IICA and OIRSA.

### Goal 4: "Encourage the participation of all Codex Members throughout the standard-setting process"

- 18. During the "Regional Workshop for the popularization of Codex Alimentarius work in CCLAC countries 2022-2024", organized in February 2024, it became evident that CCLAC Member States have maintained the same overarching approach throughout the standard-setting process, which is reflected in the responses to circular letters, leadership or joint leadership in EWGs, and the publication of CRDs.
- 19. Some members worked on proposals to adapt and update national regulations in line with the Codex Alimentarius.
- 20. Experience was also exchanged on the organization and functioning of the National Committees. One of the main challenges in the Region is keeping delegates updated with relevant Codex information due to high staff turnover.
- 21. The need to maintain strong national organizations within Member States by increasing the active participation of their delegates in the various Codex committees and reducing participation barriers was recognized, especially as economic factors prevent the region from being active in all the Codex forums despite its best intentions.
- 22. The most significant activities carried out in the last biennium are as follows:
  - Regional event on World Food Safety Day: for the third consecutive year, the international and regional organizations CCLAC, IICA, FAO, OIRSA and PAHO/PANAFTOSA came together to celebrate World Food Safety Day (WFSD) and highlight the importance of food safety for better health. Two activities were held to celebrate this day: a webinar attended by various experts from the region and a digital drawing competition. Both were intended to promote food safety to improve our health. The event was held in a virtual format on 5-6 June 2023, with some 350 delegates participating. The 2024 edition will take place on 5 June.

PAHO and the Codex Trust Fund (CTF) are holding a series of regional training workshops, specifically designed to meet the needs and requirements of countries and Codex. The workshops are part of activities organized by the World Health Organization (WHO) to provide Member States, industries and consumers with better scientific knowledge, technical tools and messages. These workshops are aimed at Member States at different levels of progress in their national Codex systems, while taking into account their available risk management capacity. The first series of workshops will focus on the establishment of maximum limits for chemical contaminants in food (MLs). This workshop was designed to create an environment where attendees can acquire new skills and knowledge in a dynamic and engaging way, using a combination of different training formats including short lectures, discussions, brainstorming sessions, practical exercises, role-plays and case studies. The workshop was attended by experts from the WHO Standards for Scientific Advice on Food and Nutrition Unit in Geneva, who taught participants about the following topics using presentations and practical exercises:

- working principles for risk analysis to be conducted within the framework of the Codex Alimentarius.
- risk assessment of chemicals in food: hazard identification and characterization, exposure assessment and risk characterization - Introduction with examples.
- chemical risk: problem definition, scope of risk assessment.
- basic statistical concepts necessary for chemical risk assessment.
- sampling strategies
- assessment of dietary exposure to chemicals: different approaches, data required, estimation of chronic and acute exposures, interpretation of exposure estimates and their limitations.
- ML setting procedures, data requirements and criteria used.
- tools for data gathering and organization: surveys and monitoring of food contamination and consumption.
- risk management options (case studies).

Thirteen countries from the region participated: Argentina, Brazil, Chile, Costa Rica, Cuba, Ecuador, El Salvador, Honduras, Guatemala, Panama, Paraguay, Peru, and Uruguay. The event was held in person in Quito, Ecuador, from 19-23 June 2023, with some 25 delegates taking part every day.

- Codex ABC regional training: the Latin American and Caribbean Region (CCLAC) held a Codex ABC training session with the support of the Codex Secretariat and the Inter-American Institute for Cooperation on Agriculture (IICA). The topics covered were the foundations of Codex, its importance in food safety, fair trade in food and standard setting. The eight steps for setting standards and each of the factors involved in the process were reviewed. The session simulated an Electronic Working Group (EWG) in order to introduce new delegates to this topic and explain how to add comments and the roles of each Member when setting up an EWG. One Member State also helped describe the operation of the Codex Online Comment System (OCS). Costa Rica and Guyana presented in 2023 and Honduras and Saint Lucia in 2024. These countries described the setting up of their National Committees and their internal processes for generating information on Codex. This was a great opportunity for the countries to showcase their own success stories. The main objective of the training was to reinforce the knowledge of delegates from the region, encouraging active participation in each of the Codex activities. The event was held virtually with translation into Spanish, English and French on 31 August and 5 September 2023 and on 03 and 05 April 2024. More than 250 delegates participated in each event on each day.
- Analytical measurement uncertainty in Codex Alimentarius: this webinar was an opportunity to learn about challenges and methods for addressing uncertainty in food measurement according to the standards set by the Codex Alimentarius and to gain insight into a document of great relevance to food measurement.

The event targeted staff from governmental laboratories dealing with health, agriculture, environment and metrology institutes in the Latin American and Caribbean region (CCLAC). The first session focused on general aspects of measurement uncertainty, providing a theoretical basis for understanding the importance of the subject. The second session explored the content and applications of Codex CXG 54-2004 in greater depth, providing attendees with a practical and up-to-date guide to uncertainty management in a laboratory setting. Exhibitors from Germany, Chile and Uruguay took part. The event was held on 12-13 September 2023 and was attended by some 800 delegates.

• South-South cooperation: comparative visit to the Codex Contact Point in Ecuador: this visit took place as part of the binational Codex Alimentarius Trust Fund project "Development of capacities for the strengthening and effective management of the Codex Contact Points, the National Codex Commission and the national Codex mirror committees in Guatemala and El Salvador", based on the principles of South-South Cooperation. A delegation from El Salvador and Guatemala visited Ecuador in order to learn about the responsibilities and competencies of the National Codex Alimentarius Committee, its Contact Point and its technical subcommittees, with the aim of identifying areas for improvement in their national programmes and processes. The event was held in person from 18-22 September 2023, with some 15 delegates participating every day.

- Celebrating the sixtieth anniversary of the Codex Alimentarius: throughout 2024, the National Committees of Member States in the region are prioritizing sixtieth anniversary celebrations with the aim of highlighting the work done for the Codex Alimentarius. This is taking place through National Symposiums, workshops, lectures, and training activities, which will highlight important actions in this field. The main objectives of these events have been:
- to establish an information forum highlighting the importance of the Codex Alimentarius, through the application of its standards, guidelines and codes of practice, and emphasizing the importance of food safety.
- to raise awareness among stakeholders about the aims of the Codex Alimentarius regarding consumer health protection and the application of fair practices in the food trade.
- Capacity building on Codex topics for the Latin American and Caribbean region: Ecuador's Plant and Animal Health Regulation and Control Agency (AGROCALIDAD), acting as Chair of the Codex Coordination Committee for Latin America and the Caribbean, and FAO's Regional Office for Latin America and the Caribbean are joining forces under the project Action to support implementation of Codex AMR Texts (ACT) to offer a series of webinars to popularize and promote the application of Codex Alimentarius standards to strengthen food safety system in the countries. The seminar series is being broadcast from 2022 to 2025 throughout Latin America and the Caribbean, in Spanish and English. Some 950 delegates have taken part to date.

Five modules have been delivered as webinars. These were:

- Module 1: Guide and orientation for new Codex Alimentarius participants.
- Module 2: Basic Codex texts.
- Module 3: Future challenges in food safety.
- Module 4: Application of Codex.
- Module 5: One Health.
- Module 6: Contaminants in fishery and aquaculture products.
- Training on the use of the Global Environment Monitoring System / Food Contamination
  Monitoring and Assessment Programme (GEMS/Food) database: this virtual training event took
  place on 07 May 2024 with the support of OIRSA. Member State delegates must learn about the
  database to boost participation and encourage the generation of scientific data in support of Codex
  expert bodies. The next training event will be held on 21 May 2024. The topic is Quantitative evaluation
  of chemical risks for the preparation of country positions in the Codex Alimentarius Commission and
  Committees.
- 23. Through the support of the Food and Agriculture Organization of the United Nations (FAO), the World Health Organization (WHO), the Codex Trust Fund (CTF), the Pan American Centre for Foot and Mouth Disease and Veterinary Public Health (PAHO/WHO-PANAFTOSA), the International Regional Organization for Plant and Animal Health (OIRSA) and the Inter-American Institute for Cooperation on Agriculture (IICA), more than 4,000 participants have attended the various activities held in the last biennium. These are just a portion of the 8,600 participants that we have reached out to under Ecuador's period as Coordinator of the CCLAC, from the beginning of its term until May 2024.
- 24. Ecuador wishes to express its deep gratitude to all government delegates from the CCLAC and other regions, to international, regional and local organizations, as well as to observer organizations and their affiliates in the region and in Ecuador for their invaluable support for the country's work as coordinator of the FAO/WHO Coordinating Committee for Latin America and the Caribbean.

25. This regional plan aims to build on the experience in CCLAC22 for the implementation of the 2020-2025 Strategic Plan, while providing countries of the region with enough flexibility to carry out this task.

26. Based on work undertaken and completed in the region over the past two years, **Appendix III** proposes possible activities to be implemented by the CCLAC for consideration by Member States during the period 2024-2025.

#### **CODEX COMMUNICATION WORKPLAN 2022-2024**

- 27. A communication work plan was also agreed through the above EWG with the aim of establishing clear communication channels between Member States and the Codex Secretariat.
- 28. Indicators were used to evaluate the activities carried out and highlight possible areas for improvement. Member States have been in direct communication with the Codex Secretariat for the publication of news, stories and capacity building initiatives in the region, with support from institutions such as FAO, WHO/PAHO and CTF, OIRSA and IICA. This has proved a simple and effective communication method for reporting on the progress of activities in the region.
- 29. **Appendix II** describes progress in achieving our goals and countries are invited to review and analyse the information provided.

#### **RECOMMENDATIONS**

- 30. CCLAC is invited to:
  - i. take note of work done in the region to support the implementation of the Codex Strategic Plan 2020-2025 (Appendix I and Appendix II);
  - ii. rate the timeliness, accessibility and quality of Codex regional communications as "excellent" or "good" (Appendix II, Objective 2);
  - iii. discuss and adopt suggested activities for implementation in the region in 2024-2025, to provide guidance for the implementation of activities in line with the region's priorities (**Appendix III**); and
  - iv. discuss how Member States can improve participation, information-sharing and communication regarding activities implemented under the Codex Strategic Plan 2020-2025.
