**REPORT OF THE IN-SESSION WORKING GROUP ON THE IMPLEMENTATION OF THE STRATEGIC  
PLAN 2020-2025**

## 1. INTRODUCTION

1.1. An in-session working group was established by CCEURO31 to consider paper CX/EURO 19/21/10 and any other relevant information (Agenda item 3.2 and CRD4) and to prepare recommendations for consideration by the Plenary on the activities to be implemented in the region in the next two years to support implementation of the Codex Strategic Plan 2020-2025 (Appendix III of document CX/EURO 19/21/10).

1.2. The working group was chaired by the United Kingdom. The Chair recalled the importance of inclusivity and collaboration and that all Members had a responsibility for implementation of the Strategic Plan 2020-2025. The Chair further highlighted the importance of identifying priority areas of work for the region and the need for clarity on time scale and ambition.

## 2. SUMMARY OF DISCUSSIONS

2.1. The discussions were facilitated and undertaken in two phases.

### ***Phase 1: Identification of the priority goals for CCEURO***

2.2. Members were asked to review Strategic Goals 1-4 and identify their highest priority goal based on their experience and needs. Using this approach, Goals 1 and 2 were considered as the highest priority. Goal 5 was not considered as CCEURO is not identified as one of the responsible parties for this goal.

2.3. The WG agreed to therefore focus their next round of discussions on Goals 1 and 2.

### ***Phase 2: Identification of activities***

2.4. Members were split into two sub-groups, one addressing Strategic Goal 1 and the other Strategic Goal 2. Each group considered practical and feasible activities to be implemented over the next two years and made the following proposals:

## 3. CONCLUSIONS AND RECOMMENDATIONS

3.1. The WG considered that Table 1 represented an achievable and impactful regional contribution to the implementation of the Codex Strategic Plan 2020-2025.

3.2. CCEURO31 is invited to

- i) consider and agree with the priority goals and objectives identified by the working group;
- ii) consider the activities identified by the working group and provide feedback on any refinement and revision needed; and
- iii) finalise Table 1 for inclusion in the report of CCEURO31.
