BACKGROUND

1. The 11th Session of the Committee on Contaminants (April 2017) agreed to forward the proposed draft Annex for the Prevention and Reduction of Ergot and Ergot Alkaloids Contamination in Cereal Grains for adoption at Step 5/8 (with omission of Steps 6 and 7) by the 40th Session of the Codex Alimentarius Commission and inclusion in the COP for the Prevention and Reduction of Mycotoxin Contamination in Cereals (CAC/RCP 51-2003).¹

REQUEST FOR COMMENTS

2. Codex members and observers are invited to submit comments on the proposed draft Annex, which is uploaded to the Codex Online Commenting System (OCS): <https://ocs.codexalimentarius.org/>, as per the general guidance below.

3. Comments should be submitted through the Codex Contact Points of Codex members and observers using the OCS.
4. Contact Points of Codex members and observers may login to the OCS and access the document open for comments by selecting "Enter" in the "My reviews" page, available after login to the system.
5. Contact Points of Codex members and observers organizations are requested to provide proposed changes and relevant comments/justifications on a specific paragraph (under the categories: editorial, substantive, technical and translation) and/or at the document level (general comments).
6. At the end of the commenting period, the Codex Secretariat will compile comments in a relevant working document using the system.
