REQUEST FOR COMMENTS

2. Codex members and observers are invited to submit comments on the revised food additives provisions of the *standards Pickled Cucumbers (CXS 115-1981)*, *Canned Bamboo Shoots (CXS 241-2003)*, and *Jams, Jelles and Mamalades (CXS 296-2009)* as presented in REP20/PFV, Appendix VII, Part B which is uploaded to the Codex Online Commenting System (OCS): <https://ocs.codexalimentarius.org/>, as per the guidance below.
3. Comments should address whether the revised food additives provisions of the *standards Pickled Cucumbers (CXS 115-1981)*, *Canned Bamboo Shoots (CXS 241-2003)*, and *Jams, Jelles and Mamalades (CXS 296-2009)* are ready for adoption or not; and if not, provide the rationale and proposals to facilitate adoption. Comments should be provided in conformity with the *Procedure for the Elaboration of Codex Standards and Related Texts (Part 3 – Uniform Procedure for the Elaboration of Codex Standards and Related Texts)*, Procedural Manual of the Codex Alimentarius Commission.
