BACKGROUND

1. See REP23/PR54¹, paragraph 209(i)(a) and Appendices VIII and IX.

REQUEST FOR COMMENTS

2. Codex members and observers are invited to submit comments on the revision of the *Classification of Food and Feed (CXA 4-1989)* and the potential consequent amendments to the *Principles and Guidance on the Selection of Representative Commodities for the Extrapolation of MRLs for Pesticides to Commodity Groups (CXG 84-2012)* as the classes in the Classification are interlinked with their corresponding tables of representative commodities in the Principles and Guidance. Comments on Tables 9 and 10 are therefore requested based on comments made on Class B and Class E of the Classification which may impact on the representative commodities and examples described in these tables.
 1. Class B – Primary Food Commodities of Animal Origin and
Class E – Processed Foods of Animal Origin
 2. Tables 9 – Examples of Representative Commodities for Class B and
Table 10 – Examples of Representative Commodities for Class E
3. In addition to what is explained in paragraph 2, comments should primarily address **whether Class B and Class E and corresponding Tables 9 and 10 of representative commodities are ready for adoption or not.** If not, provide the rationale and proposals to facilitate adoption.
4. Comments should be provided in conformity with the *Procedure for the Elaboration of Codex Standards and Related Texts (Part 3 – Uniform Procedure for the Elaboration of Codex Standards and Related Texts, Procedural Manual of the Codex Alimentarius Commission.*
5. Codex members and observers are encouraged to submit comments in reply to this CL² in order to facilitate decision-making at the 46th Session of the Codex Alimentarius Commission.
6. Class B and Class E and corresponding Table 9 and Table 10 are uploaded to the Codex Online Commenting System (OCS): <https://ocs.codexalimentarius.org/>, as per the guidance below.

7. Comments should be submitted through the Codex Contact Points of Codex members and observers using the OCS.
8. Contact Points of Codex members and observers may login to the OCS and access the document open for comments by selecting “Enter” in the “My reviews” page, available after login to the system.
9. Contact Points of Codex members and observer organizations are requested to provide general comments at the document level. Additional guidance on the OCS comment categories and types can be found in the OCS Frequently Asked Questions (FAQs)³.
