### Introduction

The objective of this meeting is to provide Members and Observers with an opportunity to make progress on the revision of Class B and Class E, based on the information provided in the working documents and comments submitted in reply to the relevant circular letter, in order to guide further work in the EWG and enable completion of work at the next session of CCPR.

The meeting also provides an opportunity to consider issues related to the establishment of maximum residue limits (MRLs) for okra as well as issues of common interest to CCPR and CCRVDF. This concerns the harmonization of terms/definitions to facilitate the establishment of single/harmonized MRLs for compounds with dual use for edible animal tissues based on the information provided in the working documents and comments submitted in reply to relevant circular letters.
