### INFORMATION NOTES

**Draft maximum levels for deoxynivalenol (DON) in cereal-based foods for infants and young children; in flour, meal, semolina and flakes derived from wheat, maize or barley; and in raw cereal grains (wheat, maize and barley) including sampling plans for raw cereal grains (Agenda Item 9):** The Committee agreed to hold at Step 7 the draft MLs and sampling plans.
