## **BACKGROUND:**

 The Twenty-fifth Session of the Codex Committee on Fats and Oils (CCFO25) agreed to forward the following proposed revisions to the Standard for Named Vegetable Oils (CODEX STAN 210-1999):

- i. PART 1: Addition of Palm oil with High Oleic Acid (OXG) (in section 2.1 Product definition and in section 3.1, Table 1)<sup>1</sup>, at Step 5;
- ii. PART 2: Peanut Oil (in section 3.1 Table 1 and in Appendix Table 2, Table 3 &Table 4)<sup>2</sup>, at Step 5/8;
- iii. PART 3: Food Additives (in section 4.1)3, for adoption;
- iv. PART 4: Appendix: Other Quality and Composition Factors<sup>4</sup> (in section 2 Composition Characteristics), for adoption.

## **REQUEST FOR COMMENTS**

- 2. Codex members and observers are invited to submit their comments on the proposed revision to the Standard for Named Vegetable Oil as indicated in para. 1 above. Comments should be provided through the Codex Online Commenting System (OCS) <a href="https://ocs.codexalimentarius.org/">https://ocs.codexalimentarius.org/</a>, where the proposed revised sections indicated in para. 1 above have been posted.
- 3. Comments should be provided as per the general guidance below.
