NOTES ON THE PROVISIONAL AGENDA

Opening of the Session: The Session will be opened by the representative of the host country.

Agenda Item 1. Adoption of the Agenda (Doc. Ref. CX/NFSDU 07/29/1). In accordance with Rule VII.2 of the Rules of Procedure, the first item on the Provisional Agenda shall be the adoption of the Agenda.

Agenda Item 2. Matters Referred to the Committee by the Codex Alimentarius Commission and/or Other Codex Committees (Doc. Ref. CX/NFSDU 07/29/2). The Committee is invited to consider matters referred to it by the Codex Alimentarius Commission and/or other Committees. The document is based on the information prepared by the Codex Secretariat.

Agenda Item 3. Guidelines for the Use of Nutrition Claims: Draft Table of Conditions for Nutrient Contents (Part B Containing Provisions on Dietary Fibre) at Step 7 (Doc. Ref. CL 2007/3-NFSDU) Following the decision of the 28th session of the CCNFSDU, the above Circular Letter was issued asking comments and additional input on the definition of dietary fibre. Comments at Step 6 are incorporated in document CX/NFSDU 07/29/3.

Agenda Item 4. Draft Revised Standard for Gluten-Free Foods at Step 7 (ALINORM 07/30/26, Appendix IV and CRD 1). The 28th Session of the Committee agreed to return the Draft Revised Standard to Step 6 for comments and consideration at the current session. CRD 1 to be prepared by the *ad hoc* Working Group chaired by Sweden and co-chaired by Canada. Comments at Step 6 would be compiled in CX/NFSDU 07/29/4.

Agenda Item 5. Proposed Draft Revision of the Advisory List of Nutrient Compounds for Use in Foods for Special Dietary Uses Intended for the Use by Infants and Young Children at Step 7 (Doc. Ref. ALINORM 07/29/26, Appendix V). The 28th session of the CCNFSDU advanced the above document to the Commission for adoption at Step 5. Comments at Step 6 would be compiled in CX/NFSDU 07/29/5.

Agenda Item 6. Proposed Draft Recommendations on the Scientific Basis of Health Claims at Step 4 (Doc. CX/NFSDU 07/29/6). The 28th session of the CCNFSDU agreed to retain the above document at Step 4 for further consideration by the 29th session. Document CX/NFSDU 07/29/6-Add.1. would contain comments at Step 3 issued for the 28th session of the CCNFSDU.

Agenda Item 7. Application of Risk Analysis Principles by the Committee on Nutrition and Foods for Special Dietary Uses at Step 4 (Doc. Ref. CX/NFSDU 07/29/7). Following the decision of the 28th Session of the CCNFSDU a document on this matter, pending approval of the 30th session of the Commission, to be prepared by Australia. Comments at Step 3 would be issued as CX/NFSDU 07/29/7-Add.1.

Agenda Item 8. Discussion Paper on the Proposals for Additional or Revised Nutrient Reference Values for Labelling Purposes (Doc. Ref. CX/NFSDU 07/29/8). Proposals for additional and revised NRVs for labelling purposes will be prepared by Korea.

Agenda Item 9. Discussion Paper on the Production and Processing Standards Regarding the Nutritional Quality and Safety of Food (Doc. Ref. 07/29/9). Following the decision of the 28th session of the CCNFSDU a paper on this matter to be prepared by Canada.
