- 1. The 30<sup>th</sup> Session of the Committee on Fish and Fishery Products advanced to Step 5 of the Procedure the proposed draft *Standard for Smoked Fish*, *Smoke-Flavoured Fish and Smoke-Dried Fish* (ALINORM 10/33/18, para. 98 and Appendix VI) and the proposed draft *Standard for Fish Sauce* (ALINORM 10/33/18, para. 144 and Appendix IX).
