The M.A. is a one year international post-graduate programme taught in English, specially designed for students wishing to work and obtain leadership positions in Italian and international institutions and organizations operating in the field of international co-operation to development, both in public and private sectors.

This programme seeks to provide skills in the following areas:

- Preparation, analysis and management of development co-operation programmes aimed at promoting growth;
- Support to the internationalisation of businesses in developing countries.

Course work content

The M.A. programme adopts a multidisciplinary approach while placing particular emphasis on the economic and financial aspects of development. The content is divided into modules according to the following topics:

- The analysis of development factors and problems;
- In depth study of the policies and intervention programmes applied by the various international and national institutions involved in international co-operation;
- The study of the specific techniques involved n the creation, evaluation and management of development programmes and projects.

Core modules include:

- Quantitative Methods;
- Development Economics;
- Planning Sustainable Development: Project and Programme Evaluation;
- International Development Assistance;
- International Economics: Trade and Finance;
- The Ethical and Social Approach to Development;
- Workshops, Seminars and Testimonials.

Internships

At the end of the programme, at least a two-month internship is foreseen at one of the businesses, NGOs, institutions, national and international bodies involved in international co-operation activities in developing countries.

Teaching staff

The teaching staff of the M.A. includes professors from the Faculty of Economics of the University of Rome "Tor Vergata", professors from other Italian and foreign Universities, researchers and experts from institutions, bodies and firms operating in the field of development economics and international co-operation.
