Background (1 of 2)

- In 2010:
 - FAO's 31st Regional Conference for Latin America & Caribbean (LAC), identified promotion of Urban / Peri-Urban Agric (UPA) as medium-term priority

 COTED endorsed FAO-CARICOM Regional Food & Nutrition Security (FNS) Policy

Background (2 of 2)



- Recent food price volatility raised awareness of importance of UPA as source of FNS:
 - supply food and generate employment & income for urban poor
 - leads to balanced &improved urban development
- Needs for unlocking UPA's full potential in LAC:
 - develop conducive institutional framework
 - identify and address gender gaps
 - provide training & extension services to producers

UPA International Seminar



- Date: 14-17 May 2012, as a side event at 4th
 International Tropical Agriculture Congress, Cuba
- Venue Convention Centre, Havana, Cuba
- Funding: FAO (participants, resource persons)
- General Objective:
 - Contribute to regional coordination / collaboration among programmes & projects on UPA, aimed at establishing a regional strategy and programme on UPA to enhance FNS in LAC

Highlights of Cuban UPA



- Dedicated training institution (under INIFAT)
- High level of education, strong legal framework
- Use of semi-protected/protected systems for year-round vegetable production
- Maximum plant diversity in production units
- IPM strategies, use of organic materials for soil improvement and amelioration
- Articulated, intensive Monitoring & Evaluation

Challenges, Opportunities for UPA

Major Challenges (Caribbean)

- Lack of:
 - legal, institutional frameworks
 - quality planting material
 - quality seed production facilities
 - appropriate monitoring mechanisms and tools
- Know-how to sustain and increase soil fertility
- Water: availability, quality, monitoring strategy
- Limited land availability, particularly in SIDS

Major Challenges (C. America)

- Documentation, expansion of UPA experiences
- Revision of the use of demonstration centers in UPA projects as a training approach
- Establishment cost and sustainability
- Research on integration and impact of produce in urban market and food supply systems
- Essential to share experiences, lessons learnt on family farming policies to avoid duplication of effort and delay in implementing policies

Opportunities



- UPA promotes social interaction and a two-way exchange of information & experiences in LAC
- UPA can provide vital service to meet national demand for clean, fresh, nutritious produce
- Good business opportunity: production of quality, affordable seeds and planting material

Recommendations



- Strategy elements for regional approach to UPA:
 - research on adaptation of methods & technologies
 - distance learning, meetings/workshops, technical cooperation, and networking
 - generation, youth and gender considerations
 - participatory processes: focus on producer-toproducer knowledge sharing & knowledge management, self management capacity
 - use of communication media for development and networking

Recommendations



- Strategy elements for regional approach (cont'd)
 - local diagnosis of producers' interests and needs,
 and clustering producers by interests and needs
 - integration, coordination among & between
 Government and NGO programs and organizations

• In C. America:

- Governments / municipalities to review, assess & institutionalize completed projects.
- Public policy needs to embrace UPA at all levels

EXPRESSED

Support for World Food Summit declaration: "Food Security exists when all people at all times, have physical, social and economic access to sufficient, safe and nutritious food which meet their dietary needs and food preference for an active and healthy life"

CONSIDERING

That Food and Nutrition are inalienable human rights and that UPA contributes significantly to food and nutrition security of the countries of the region



RECOGNIZING

That development of UPA contributes to FNS of countries of the region and also recognizing cultural traditions and increases in educational levels of the population

That it is necessary to identify, characterize, exchange and conserve genetic resources because of their contribution to food security, while respecting national sovereignty



URGED AND RECOMMENDED

Promotion & encouragement of implementation of public policies and action plans to support UPA development with an agro-ecological production approach in order to facilitate access to and availability of healthy food for all and taking into consideration local know-how and traditions

FAO to advice on the definition and implementation of policies and action plans for development of UPA in the region

The Way Forward



- 1. Creation of region-wide framework focusing on on two modalities of family farming, UPA, differentiated by location, scale, commodity and language (Spanish, English), but with common management and monitoring tools
- Research, publish & disseminate sustainable technologies developed by previous projects & experiences of Cuban UPA (Spanish, English) that can benefit other countries

The Way Forward



- 3. Promote 'Havana Declaration for UPA 2012':
 - UPA activities should be taken up by CARICOM,
 NGOs, other interested groups working on UPA
- 4. Adopt concept of Family Farming (per FAO definition), covering a population segment with wide variety of physical, financial, human and social resources that are different in each country, but the type of agriculture shares a number of common characteristics
