## Guide to CFS 50

### WELCOME TO CFS 50

Welcome to the fiftieth plenary session of the Committee on World Food Security (CFS 50), to be held from **10-13 October 2022**.

The Plenary will start with a special ministerial-level segment to focus on the state of food insecurity in the world and on fostering coordinated policy responses to the global food crisis, due to the COVID-19 pandemic, ecological and economic shocks, the conflict in Ukraine and protracted crises elsewhere. It will be kicked off by a discussion of the 2022 State of Food Security and Nutrition in the World report (SOFI), and will address structural causes of hunger and malnutrition. The 50th plenary session will celebrate the International Day of Rural Women, address preparation of CFS Voluntary Guidelines on Gender Equality and Women's and Girls Empowerment, and endorse CFS Policy Recommendations on Promoting Youth Engagement and Employment in Agriculture and Food Systems for Food Security and Nutrition.

In addition, the Plenary will deliberate on the CFS's strategic direction to accelerate action on SDG-2, kick off a CFS policy convergence process on Data Collection and Analysis Tools for Food Security and Nutrition, and review ways of boosting responsible investment in sustainable agriculture and food systems through a global thematic event, where the Committee will take stock of the uptake of CFS Principles for Responsible Investment in Agriculture and Food Systems (CFS-RAI). The session will also feature a Special Event organized by the CFS Secretariat on follow-up to the September 2021 UN Food Systems Summit, including sharing progress on implementing national transition pathways by volunteer Members.

### II. MINISTERIAL SEGMENT: COORDINATING POLICY RESPONSES TO THE GLOBAL FOOD CRISIS - THE STATE OF FOOD SECURITY AND NUTRITION IN THE WORLD 2022 *(for information and discussion)*

Today, conflict, climate variability and extremes, economic slowdowns and downturns (exacerbated by the COVID-19 pandemic) are recognized as the major drivers of the recent rise in hunger and food insecurity.

This year, the State of Food Security and Nutrition in the World (SOFI) 2022 report estimates that between 702 and 828 million people were affected by hunger in 2021. The number has grown by about 150 million since the outbreak of the COVID-19 pandemic – 103 million more people between 2019 and 2020, and 46 million more in 2021. Projections are that nearly 670 million people will still be facing hunger in 2030, which is the same as in 2015 when the 2030 Agenda was launched. Moreover, almost 3.1 billion people could not afford a healthy diet in 2020, reflecting the inflation in consumer food prices stemming from the economic impacts of the COVID-19 pandemic and the measures put in place to contain it. In this scenario, the war in Ukraine adds to preexisting shocks, seriously threatening global food security and nutrition, and making coordination of global policy responses critical and urgent.

Following a presentation of the 2022 State of Food Security and Nutrition in the World report, updates by the UN Global Crisis Response Group and an oral briefing on the High-Level Special Event held on 18 July in New York on responses to the global food crisis, delegates from across the globe will then have the opportunity to

make interventions, highlighting their analysis of the situation at the country level, policy options for the way forward, as well as the role CFS is expected to play as it strives to achieve its vision “for a world free from hunger where countries implement the voluntary guidelines for the progressive realization of the right to adequate food in the context of national food security”.

This item will continue in the afternoon with delegations’ statements. The Special Rapporteur on the right to food, Mr Michael Fakhri, will introduce his report “*The right to food and the coronavirus disease pandemic*” that he prepared and presented to the General Assembly. CSIPM will also be invited to present the results of their Report “*Responding to the New Layer of Global Food Crisis: lived experiences on the ground and people’s policy demands*”.

At the end of the session, draft conclusions will be presented for discussion and endorsement by Plenary.

### 2. CFS VOLUNTARY GUIDELINES ON GENDER EQUALITY AND WOMEN’S AND GIRLS EMPOWERMENT IN THE CONTEXT OF FOOD SECURITY AND NUTRITION

The preparation of the CFS Voluntary Guidelines on Gender Equality and Women’s and Girls Empowerment in the Context of Food Security and Nutrition (VGs on GEWGE) was agreed by CFS Plenary in October 2019, as part of the MYPoW 2020-2023. Draft Guidelines were developed based on the Terms of Reference approved in February by CFS 2021, and an inclusive and multi-stakeholder process, which included Open-Ended Working Group meetings, six regional consultations, a global electronic consultation and three week-long negotiation sessions. The process was supported by a Technical Task Team composed of experts nominated by CFS Advisory Group constituencies.

This session will provide an opportunity to reflect on the achievements to date, and determine the way

forward as a Committee to advance gender equality and women's and girls' empowerment, in accordance with the current MYPoW.

## IV. CFS STRATEGIC DIRECTION TOWARD 2030 *(for discussion and decision)*

The objective of this agenda item is to encourage meaningful discussions among CFS stakeholders on the strategic direction that the Committee should take to accelerate action on SDG2 ("End hunger, achieve food security and improved nutrition and promote sustainable agriculture") to achieve all SDGs.

In line with the provisions of Annex B of the CFS Implementation Report on the new MYPoW structure and process (CFS 2022/50/Inf.17, adopted at CFS 45), this session is designed to support CFS in fulfilling its role as *"the foremost inclusive international and intergovernmental platform for a broad range of committed stakeholders to work together in a coordinated manner and in support of country-led processes towards the elimination of hunger and ensuring food security and nutrition for all human beings"*.

**Session Rollout:**

### 1. CRITICAL, EMERGING AND ENDURING ISSUES FOR FOOD SECURITY AND NUTRITION *(for discussion)*

This section will set the stage for the preparation of the 2024-2027 CFS MYPoW, which is expected to be developed in the 2022-2023 intersessional period and endorsed at CFS 51. CFS stakeholders will have the opportunity to share their views and suggestions on potential issues to be addressed by the Committee on the basis of the HLPE-FSN note on Critical, Emerging and Enduring Issues (CFS 2022/50/Inf.16).

The outcomes of the discussion will be captured through a short CFS Chairperson's Summary as part of the draft conclusions, for consideration and endorsement by Plenary. A more exhaustive Chairperson's Summary will be developed and circulated after the Plenary.

### 2. UPDATE OF THE ROLLING SECTION OF THE CFS MYPoW 2020-2023 *(for decision)*

CFS Members will be asked to consider the annual update of the rolling section of the CFS 2020-2023 MYPoW, as prepared by the Bureau in consultation with the Advisory Group. The CFS Chair will introduce document CFS 2022/50/6 and invite interventions by CFS stakeholders.

Following discussion, a draft decision will be presented for endorsement by Plenary.

CFS members will select the theme of the 2024 HLPE-FSN report on the basis of a proposal prepared by the CFS Bureau, in collaboration with the Advisory Group (CFS 2022/50/7).

- Ms Claire Melamed, CEO, Global Partnership for Sustainable Development Data (GPSDD), will deliver a keynote speech highlighting the relevance of data – as means of implementation - for monitoring progress or setbacks on SDG2, and as instruments for grounding food systems transformation policies that deliver on food security and nutrition for all.

### 2. DELEGATES DISCUSSION ON THE FINDINGS OF THE REPORT

Delegates are encouraged to share their views on the basis of the following guiding questions:

1. What are the priority policy areas to be addressed by the CFS policy convergence process?
2. How can CFS foster the production, analysis and use of data for supporting food security and nutrition-related policy-making?
3. Are there any relevant initiatives and experiences on strengthening production, analysis, dissemination and use of data in agriculture and food systems that CFS can build upon?

In this part, polls may be used to enhance interaction with the audience, and short videos used to highlight voices of food producers and other stakeholders.

Following the release of a dedicated report by CFS High Level Panel of Experts on Food Security and Nutrition (HLPE-FSN) in 2021 and multistakeholder consultations and negotiations in 2022, this session is expected to seek plenary endorsement of the CFS policy recommendations on Promoting Youth Engagement and Employment in Agriculture and Food Systems for Food Security and Nutrition.

This session will also provide an opportunity for CFS stakeholders to share ideas and proposals on how to promote dissemination, use and application of the policy recommendations at all levels to contribute making agriculture and food systems more attractive to young people and increase their capacity to generate decent employment opportunities and livelihoods.

## VII. BOOSTING RESPONSIBLE INVESTMENT IN SUSTAINABLE AGRICULTURE AND FOOD SYSTEMS. GLOBAL THEMATIC EVENT ON THE CFS PRINCIPLES FOR RESPONSIBLE INVESTMENT IN AGRICULTURE AND FOOD SYSTEMS *(for information and discussion)*

Climate change, conflicts, the COVID-19 pandemic, and the increasing cost of food are having significant negative impacts on global food supplies, access to food, and long-term sustainable development. This will damage prospects for the most marginalized and vulnerable as well as for the achievement of the SDGs, particularly SDG2 on Zero Hunger.

More and smarter investments in agriculture and food systems are needed. While we face a food crisis - with spiking agricultural input and fuel prices, there is also an opportunity to transform global food systems towards more resilient food supply chains through more sustainable practices and the empowerment of smallholders, family farmers, SMEs and cooperatives – especially women and youth.

Financing for Development in the era of COVID-19 and beyond, presents an opportunity to make bold choices that were considered by Heads of State and Government on the Margins of the UNGA in September 2020. This will support countries in pursuit of ways and means to build back forward and greener from the COVID pandemic. Responsible investments in agriculture and food systems – the ones that impact positively on all three dimensions of sustainable development and on all the 17 SDGs - can enhance food security and nutrition and support the progressive realization of the right to adequate food in the context of national food security.

How much will it cost to properly finance sustainable and inclusive food systems that are not just capable of ending hunger and malnutrition, but simultaneously eradicate poverty, reduce inequalities in all their dimensions, and deliver on climate, biodiversity, soils and the rest of the SDGs? What needs to be done to unleash the billions of public and private resources needed to achieve SDG 2?

This CFS-50 Global Thematic Event (GTE) will examine these questions and take stock of the uptake of the interconnected and complementary [Principles for Responsible Investments in Agriculture and Food Systems](#) (CFS-RAI) that provides a framework to guide actions of stakeholders engaged in agriculture and food systems. The GTE will offer an interactive multi-stakeholder dialogue to share experiences and good practices in the use and application of the CFS-RAI.

The event is informed by the documented experiences and good practices of a broad range of stakeholders in the use and application of these Principles, and will contribute to monitoring progress in implementing the CFS-RAI at global, regional and national levels.
