Background

In recent years, there has been increasing awareness about the importance of leveraging the law-making, budget-allocation, oversight and representational mandate of parliamentarians for food security and nutrition (FSN). Engaging with parliamentarians helps put FSN at the highest level of legislative, political and budgetary agenda.

Recognizing the cross-cutting nature of FSN, a number of parliamentary alliances that go beyond the traditional standing committees in charge of food security and/or nutrition have been established at the national, sub-regional and regional levels in different parts of the world. They have played a significant role in adopting legislation that define rights and responsibilities, and put in place coordination and accountability mechanisms.

The parliamentary alliances that are in place in the different regions and countries have made meeting the SDGs, particularly goal 2, and securing food security in times of crises part of their explicit agenda. They also seek to translate international commitments relating to FSN and the right to adequate food into national level actions. While the experience so far differs from one region to another, significant strides have been made in terms of engaging parliamentarians to advance the FSN agenda. This side event aims to bring focus on the actual and potential role of parliamentarians in legislating for FSN and supporting the implementation of the same through budgeting and oversight. It seeks to bring the work of parliamentarians into the multi-stakeholder platform provided by the CFS for collective actions to advance FSN.
