## CFS 51 draft report - item IIII: Strengthening coordinated Policy Responses to the food crisis - The State of Food Security and Nutrition in the World 2023

Mr Chair,

- 1. I am honoured to speak on behalf of the European Union and its 27 Member States.
- 2. The EU welcomes/notes [TO BE ADAPTED TO SITUATION] ...... adoption of report for agenda item 3 and would like to express the following position in this regard.
- 3. The EU is gravely concerned about the deepening humanitarian crisis in Gaza.
- 4. We welcome the agreement to release 50 hostages from Gaza for an extended pause in the conflict. We continue to call on Hamas for the immediate and unconditional release of all hostages. The Humanitarian pause must be used to provide as much urgently needed aid as possible to the civilians enduring the devastating conflict in Gaza. The EU will do its part in helping, as it has done throughout the year, with a total of 600 million euros in aid provided in 2023, of which 360 million since October 7.
- 5. The EU remains committed to the need for immediate pauses in hostilities and the establishment of humanitarian corridors, including through increased capacity at border crossings and through a dedicated maritime route, so that humanitarian aid can safely reach the population of Gaza.
- 6. In line with the European Council conclusions of 26 October and the statement of the High Representative of 12 November, the EU re-emphasizes Israel's right to defend itself in line with international law and international humanitarian law.

7. The EU and its Member States will continue to work closely with international partners, UN agencies, as well as countries in the region to provide a sustained flow of assistance and facilitate access to food, water, medical care, fuel and shelter.
