After coordinating several collective reviews on the contribution of agronomic research to innovation and development processes in Sub Saharan Africa, his research aims to better understand the nature and roles of Rural Producers' Organizations in development.

He participated in the revision of World Bank Rural Development Strategy (2001) and contributed to the World Development Report 2008 on these issues. After initiating (1998) and directing (2002-2005) a research program "Family agriculture and globalization", he conceived the International Initiative World Agriculture Watch (WAW) hosted by FAO with the support of IFAD and France to monitor the structural transformations of agriculture.

In 2012/2013, he was Project Team Leader for the HLPE Report on "Investing in smallholder agriculture for food security" which fed into CFS debates in 2013. During 2014 International Year of Family Farming he contributed to and coordinated several collective books on family farming in a worldwide perspective.

Shi Yan, the executive director of Shared Harvest (Beijing) Ecological Agriculture Service Ltd, received her PhD from the Renmin University School of Agricultural Economics and Rural Development, and has finished her postdoctoral research at Tsinghua University's School of Social Sciences.

As a young PhD student at Renmin University, she founded the first Chinese organic community-supported agriculture (CSA) farm growing and distributing organic vegetables to city consumers and renting plots of land to city folk interested in getting their hands dirty. Since then, 200-300 similar CSA farms have opened across the country. She has since moved on to establish Shared Harvest in Tongzhou and Shunyi in 2012.

She has been inspiring a healthier and more sustainable way to feed us. She is a pioneering force and active promoter behind the CSA movement. She is now the vice president of the International CSA Network(URGENCI), She has also published a book "My Alternative Farming Experience in America" and Chinese translations of three related books: "Farmers of Forty Centuries: Organic Farming in China, Korea, and Japan"; "Sharing the Harvest: A Citizen's Guide to Community Supported Agriculture"; and "Slow Money". "The Beijinger" selected her as one of the 20 most interesting people in Beijing. More than 300 media outlets in China have reported her story. She also gives public speeches and lectures to inspire more people to reconnect to land.

Mamadou Goita, is a development socio-economist and a specialist in education and training systems from Mali, West Africa. He was the executive Secretary of the West African Peasants and Farmers Networks (ROPPA) from 2011 to 2012. He is a member of the regional co-ordinating group of the "Coalition pour la Protection du Patrimoine Génétique Africain" and the "Coalition to Protect African Genetic Heritage" which operate in West Africa. He has worked with UNICEF in Mali, the United Nations Development Programme in Togo and Burkina Faso and several NGOs, including ACORD (Regional Director for West Africa and Africa Program Manager) and OXFAM-Belgium (Regional Co-ordinator for West Africa based in Burkina Faso).

He is active in social movements such as The forum for Another Mali is possible(FORAM), West Africa Social Forum, Africa Social Forum and the World Social Forum and works with farmer organizations and their networks in West Africa. He coordinated the Polycentric World Social Forum Bamako 2006 and participated to the coordination of the World Food Sovereignty Forum which took place in Sélingué, Mali in 2007.

He is the chair of the CSO Coalition on the African Development Bank, the Diobass, Ecology and Society, an international NGO working on agro ecology and the Association Malienne pour la Sécurité et la Souveraineté Alimentaire).

He was until recently a board member of Bank Information Centre and a member of the Migrants' Rights International steering committee and currently a board member of USC Canada and ETC Group.

He is a member of the scientific boards Syndicat des Exploitants Agricoles de l'Office du Niger (SEXAGON ) and the Network of African Women Economists (NAWE)

He has worked on issues like cotton, trade, extractive Industries, conflict management, governance, decentralisation and local development, migration for many years and has been involved in many economic, social or socio-economic studies, researches and evaluation processes in Africa. He teaches at the University of Ouagadougou (Burkina Faso), at the "Applied Economic National School" Dakar, Senegal and the African Management Centre (CESAG), Dakar, Senegal, was the Director of CODESRIA 2014 Institute of Governance Director. He's also a course Director on "Natural resource management and Africa Development" of the Institute of Security Studies based in Addis Ababa, Ethiopia.
