# **EXTRACT FROM THE CFS 45 FINAL REPORT**

#### 19. The Committee:

- Took note of the views expressed and the potential issues suggested during the session on critical and emerging issues for future consideration by the CFS as an important element for upcoming discussions on the preparation of the next CFS Multi-Year Programme of Work (MYPoW);
- b) In line with indications included in Annex B of the Implementation Report of the CFS Evaluation, recommended that the CFS Bureau, in collaboration with the Advisory Group, and with the support and participation of interested CFS stakeholders, work on the preparation of the CFS MYPoW 2020-2023 to be submitted for consideration and endorsement at CFS 46;
- c) Requested the HLPE to undertake the following study to be presented by the first semester of 2020: "Food Security and Nutrition: Building a Global Narrative towards 2030", as per the proposal included in section three of document CFS 2018/45/4.

## I. OVERALL OBJECTIVE

Implement a structured, inclusive and efficient process for the prioritization and selection of future CFS thematic workstreams and supportive activities, based on the indications provided in Annex B of the CFS Evaluation Implementation Report.

#### II. EXPECTED OUTCOMES

A feasible and realistic MYPoW is prepared, taking into account resources, workload, and the resource mobilization potential, and presented to the CFS Plenary in 2019 for consideration and endorsement.
