BACKGROUND

Food security, nutrition and sustainable agriculture are central to the 2030 Agenda and are crucial for achieving all of the Sustainable Development Goals. There is an urgent need to accelerate action by all stakeholders at all levels to fulfil the vision and goals of the 2030 Agenda.

According to estimates in the <u>State of Food Security</u> and Nutrition in the World 2020 report, the number of hungry and malnourished people has been slowly on the rise over the past few years with more than 690 million people in the world going hungry in 2019, and over 130 million more pushed into chronic hunger because of the COVID-19 pandemic. In addition, 2 billion people suffer from micronutrient deficiencies and the number of adults who are overweight or obese is ballooning - putting them at higher risk of contracting serious noncommunicable diseases (like heart attacks, diabetes, and various cancers). On top of this, over 3 billion people cannot afford a healthy diet. Diet-related illnesses are now the world's number one killer. These conditions call for profound transformation of our food systems to reverse these negative trends, taking into account interlinkages between SDG-2 and other SDGs to mitigate trade-offs and maximize synergies.

The experience of the Rome-based Committee on World Food Security (CFS) in conducting policy convergence work in an inclusive, evidence-based model of consensus-building is a good practice to be shared and learned from. Supported by all three Rome-based Agencies (FAO, IFAD and WFP), CFS is comprised of members , civil society and

non-governmental organizations, international agricultural research networks, international and regional financial institutions, relevant private sector associations, foundations, UN agency experts and others. Due to its 2009 reform, CFS is the UN's foremost inclusive international and intergovernmental platform for all stakeholders to work together to ensure food security and nutrition for all.

This 90-minute side event will highlight CFS's collaborative, multi-stakeholder contribution to international policy convergence aimed at supporting the achievement of global food security and nutrition targets. Speakers will address how CFS is working to drive progress on SDG 2, including through our recently-endorsed Voluntary Guidelines on Food Systems and Nutrition and our Policy Recommendations on Agroecological and Other Innovative Approaches.
