

WORKPLAN OF THE CFS WORKSTREAM ON REDUCING INEQUALITIES FOR FOOD SECURITY AND NUTRITION (2023-2024)

EXCERPTS FROM THE 2020-2023 CFS MULTI-YEAR PROGRAMME OF WORK (MYPoW)

49. The proposed thematic workstream will contribute to the CFS vision and the overall objective of addressing the root causes of food insecurity with a focus on the people most affected by hunger and malnutrition.

50. The focus will be on inequalities within agri-food systems. The workstream will provide an analysis, based on a HLPE report, on drivers of socio-economic inequalities between actors within agri-food systems that influence food security and nutrition outcomes. Gender inequalities and the need to create opportunities for youth would inform the analysis, so there will be scope for complementarities with other MYPOW workstreams, although the overall focus will differ from these workstreams.

89. Following the launch of the HLPE report in 2023, the identification of a Rapporteur among CFS Members and a plenary discussion at CFS 51, CFS will conduct a policy convergence process. The process will lead to the development of policy recommendations to be presented to the Committee for endorsement at CFS 52.
