Objectives

Working Group on Maximum Residue Levels (MRLs)

Present a report of the list of priority chemicals and timetable for submission to Codex; this
would include the correlation between field trial and GLP supervised protocols. Provide an
explanation on how the submission could facilitate achieving global harmonization of MRLs,
including the communication plan and the Decision Tree for discussion and endorsement.

Working Group on MRLS in Tea Brew

- Present a policy document outlining the methodology and other technical requirements to enable regulators of the CCPR to accept MRLs in the brew as the basis for risk assessment. This document would need to be discussed and endorsed for submission to the CCPR.
- Report on the ring test on a few widely used pesticides among different tea producing and consuming countries (India, China, Sri Lanka, Kenya, UK, USA and Germany).

Working Group Tea Trade and Quality

- Review the status of compliance of ISO 3720, as a minimum quality standard.
- Present a report on progress towards achieving tea trade and quality since the last intersessional
 meeting in Washington, DC, in 2012, including tabling the results of the collection of existing
 literature on additional quality benefits delivered by tea conforming to ISO 3720 or higher; the
 status of consuming importing countries complying with ISO 3720 parametres or above; and
 listing donor response to funding/technical assistance for countries requiring support in
 implementing ISO 3720 minimum quality standard.
- Report on the WG on the Establishment of Minimum Quality Standard for Green Tea.

Working Group on Organic Tea

- The Secretariat will update the intersessional meeting on generating market information and developing market strategies and on the certification process for tea production.
- Report on progress made on the technical requirements particularly the recommended package of practices – being adopted by member countries.
- Provide an update on considering organic tea as low energy input for financial gain through carbon trading and on joining the organic movement for sustainability.

Working Group on Climate Change

- Report on progress made on database development, on the impact analysis methodology, on the interaction among genotype x environment x management.
- Table a report on adaptation strategies and agronomic practices for discussion and endorsement.
- Appoint a chairperson to lead and be the focal point of this Working Group.

Working Group on Smallholders

- Present a report updating the analysis of data by origin, including the challenges and issues among smallholders.
- Provide a report on the exchange/exposure visits amongst member countries; and on educating and training smallholders.

Task Force on Statistics

 Review tea production forecasts of each member country of the Task Force and adjust production, consumption and trade projections for tea over the next ten years using the FAO World Tea Model.
