The challenges related to increasing efforts towards achieving the 2030 Agenda for mountains in our working area - the Hindu Kush Himalaya (HKH) - stems from both the global level and the level of individual national governments. Although the situation varies across the eight countries of the HKH, in general, mountain areas and issues are marginal to central government concerns. This has myriad effects in terms of national budgets, data collection and availability, political and administrative power, which is also mirrored at the global level. A recent significant effort we facilitated built on the scientific results of the comprehensive HKH Assessment report, and culminated in ministerial-level agreement on a collective HKH Call to Action to accelerate fulfillment of the SDGs in the mountains; take coordinated climate action; strengthen regional cooperation; promote a united voice for the mountains; recognize the uniqueness of mountain people; enhance ecosystems resilience; and enhance data and knowledge sharing. We anticipate that this HKH Call to Action will provide fuel for the required acceleration of efforts towards achievement of the 2030 Agenda in the HKH mountains.
