SITE SELECTION FOR KAGERA TAMP INTERVENTIONS IN RULINDO, KAMONYI, BUGESERA, NYAGATARE, KAYONZA, KIREHE DISTRICTS CONT.....

Check list for consideration while selecting sub-catchments:

- > Opportunities to contribute to at least 1 of the 4 project outputs;
- Enabling policy, planning and legal environment (community/district action planning, byelaws);
- Capacity building requirements for SLM adoption and scaling up (Development partners, Farmer groups, extension, research, agric) training opportunities;
- > Trans-boundary cooperation for SLM (i.e. cross-border areas)



CHECK LIST FOR CONSIDERATION WHILE SELECTING SUB-CATCHMENTS CONT......

- > Field diagnostic assessment using PRA& transects;
- District priorities and plans (agric. and environment, and food security, community development);
- Degree and type of degradation and causes in specific LUS (crop, pasture, forest, mixed agriculture &livestock systems-consideration of agricultural intensification programme etc...);
- > SLM types on the ground with options for improving efficiency, scaling up and generating multiple benefits;
- Value chain development;



CHECK LIST FOR CONSIDERATION WHILE SELECTING SUB-CATCHMENTS CONT......

- Mapping of intervention areas (Land degradation &Sustainable Land Management);
- Land use planning & action plans; (Participatory development, implementation and monitoring of community land management action plans);
- > Land tenure Security & access to resources;
- Identification of development organisations and other relevant projects and partners in the area that will be involved in the implementation of Kagera TAMP activities;
- Selection & establishment of Farmer Field
 School Groups in sub-catchments;
- Selection of River/lakes to be protected;
- Sensitization meetings in selected catchments and communities.



SELECTION OF SUB-CATCHMENTS & COMMUNITIES

- On the basis of site selection criteria mentioned above, sites selection & Communities were jointly performed by project beneficiaries, district technical staff and national project manager;
- The exercise started from 5th -21st July, 2011;
- > 10 sites were selected in all six target districts, and the list is as shown:
- Only 6 sites will be intervened during the rainfall season A;
- ToRs for Mapping &Diagnostic Assessment for selected sites completed;
- Identification of key activities & budgets for LoA with Rwanda Agricultural Board (RAB)& Vi-life programme completed;
- > Development of collaborative framework with the two organizations is in process.
