Extraordinary ASP meeting on 2 August 2022	 Implementation of the GSP Action Framework 2022–2030 and its impact on the region; For decision to the 11th Plenary Assembly Chairs of the RSPs to agree on a common approach to the implementation of the GSP Action Framework. Main ASP achievements in 2022-2023

Center of Excellence for Soil Research in Asia (CESRA)

- <u>1st meeting on Soil Research and Development in August 2022</u>: writing of 3 concept notes on salt-affected soils, soil erosion and soil organic carbon management
- <u>1st CESRA Forum (annual meeting) in September 2022</u>
- <u>1st CESRA's Steering Committee meeting</u> on 14 June 2023: revision of the CESRA TORs, decision on how to make CESRA more inclusive towards its members in terms of decision making and projects' formulation and implementation
- <u>2nd meeting on Soil Research and development</u> in June 2023: development of matrixes for the formulation of projects
- Launch of the <u>CESRA's e-learning platform</u>: CESRA members are now invited to contribute to it with lectures
- Launch of the <u>CESRA's database on best practices</u>: CESRA members are now invited to contribute to it with best practices on soil and land management




ASP proposals

- 1. The ASP is proposing GLOSOLAN to identify a highly competent soil testing laboratory in the region to act as a Centre of Excellence for Soil Laboratories (CESLab). CESLab will complement CESRA in soil data quality assurance, harmonization of methods, measurements and indicators for sustainable management and protection of soil resources, and training.
- 2. The ASP proposed to establish an Action Framework on Soil Health in Asia (AFSHA) to overcome the obstacles to the implementation of sustainable soil and land management at the field level in the region, avoid duplication of efforts, make a better use of the financial resources available, and set the basis for establishing regional policies on soil. Proposal endorsed at the 8th ASP meeting on 2 May 2023. FAORAP prepared the first draft of the document that will undergo an inclusive review.

AFSHA's CORE OBJECTIVE: To **create enabling socio-economic and politic environments** for the best and long-term implementation of sustainable soil and land management activities on the ground
