Being an AgWA member/partner means....

- ✓ Supporting sustained agricultural growth in Africa
- ✓ Contributing to African socio-economic development
- **how?** by pooling either financial/in kind resources or technical knowledge
- **in return...** partners belong to a wide network of AWM organizations and professionals that share interests and most-up-to date knowledge in AWM

Proposed types of membership

Funding partners

- Provide financial support (by funding projects or through the basket fund proposed)
- Do in kind contributions (office space, material and equipment, expert knowledge, etc.)
- ✓ Members in the Steering Committee
- ✓ Right to vote in partners meetings

Non funding partners

Only make in kind contributions- share interests and most-up-to date knowledge in AWM





Membership criteria

Open to any organization or network with an interest in and capacity for contributing to promotion of effective AWM in Africa.

Governments, donors, NGOs, research and educational institutions, private sector and civil society organizations at all levels (international, national).

AgWA will be more proactive in including the **civil society** and **universities/research institutions**

more specifically...

✓ Any aspect of AWM in the scope of partners' work.

- Evidence on the will to improve AWM through more environmentalfriendly socially-equitable initiatives.
- ✓ The geographical coverage of partners' work should include Africa.
- The added value of each partner and partners' commitments towards AgWA has to be justified.







Host institution



The Secretariat is currently hosted by **FAO** at its **Sub-Regional Office for Eastern Africa (SFE)** in Addis Ababa.

SECRETARIAT

Terms of reference

- ✓ Keep **communications** with partners
- ✓ Identify future partners
- Prepare terms of reference for consultants that will prepare specific reports, studies, etc.
- ✓ Supervise and support the work of consultants.
- ✓ Attend AWM related events and meetings
- ✓ Organize AgWA related events and meetings
- ✓ Support and supervise the implementation of AgWA projects
- ✓ Prepare the AgWA progress report
- ✓ Work to transform AgWA into a legal entity



STEERING COMMITTEE

Members Steering Committee to be constituted of up to 12 partners

Terms of reference

- ✓ Provide overall strategic guidance and advice to develop AgWA
- Review and approve the future Operational, Governance and Financing Plans, any major changes in the core operation of AgWA
- ✓ Review and approve major **memoranda of understanding**
- ✓ Identify opportunities for AgWA to promote AWM
- Act as champions supporting both the development of AgWA and its broader goals and objectives
- Engage African inter-governmental organizations
- Engage regional and international organizations and development partners supportive of AWM





AgWA's LEGAL STATUS

The partnership should become a legal entity at the pan-African level

Typologies

- ✓ **Registration:** international NGO, Society, or Trust.
- Based at country level (e.g. WaterNet) or to apply for registration through the African Union Commission in order to get diplomatic status (e.g. FARA).
- ✓ **Time frame** for AgWA to become a legal entity: 2–5 years
