APPOINTMENT OF INDEPENDENT CHAIRMAN OF THE COUNCIL

- 1. In accordance with Rule XXIV of the Rules Adopted by the Conference, the Council at its Thirty-First Session decided that nominations for the office of Independent Chairman of the Council should be submitted to the Secretary-General of the Conference not later than 15 September 1959, and that the Secretary-General should dispatch notification to all Member Governments of the nominations thus received not later than 19 September 1959.
- 2. By 15 September 1959 three nominations for appointment to this office had been received. These were the nomination of Don Ramón Cantos Figuerola by letter dated 11 July 1959 from His Excellency the Ambassador of Spain to Italy; the nomination of Mr. Louis Maire by letter dated 15 July 1959 from the Federal Political Department of Switzerland; and the nomination of Mr. Georges Khalil Haraoui by letter dated 4 August 1959 from His Excellency the Ambassador of the Lebanon to Italy. Member Governments were informed officially by the Secretary-General of the Conference of these three nominations in circular letters G/141 of 31 July 1959 and G/144 of 24 August 1959. The letters of nomination and curricula vitae submitted for the three candidates are appended hereto.
- 3. Under Item IV-19 of the Provisional Agenda, the Conference at its Tenth Session in November next will appoint the Independent Chairman of the Council amongst these three candidates and will also determine the conditions of appointment, including the allowances attached to the office.

At the 'Instituto Nacional de Investigaciones Agronómicas' (National Agricultural Research Institute) from 1930, successively with the 'Servicios de Fitopatología, Cerealicultura' (Plant Diseases, Grain Culture Services), and at present Chief of 'Sección de Estudios Económicos y Estadísticos' (Economics and Statistics Section).

From 1937-1939 on the staff of the 'Servicio Nacional del Trigo' (National Wheat Service) (a State grains monopoly).

From 1939, Representative of the Ministry of Agriculture in commercial bilateral negotiations at numerous conferences, congresses and international organizations (International Commission for Agricultural Industries, the "Green Pool" - European Conference on the Organization of Agricultural Markets, OEEC, EEC - European Economic Committee, FAO, etc.)

Chief of the 'Servicios de Política Comercial' (Market Policy Services) of the Ministry of Agriculture.

CURRICULUM VITAE

Dr. Louis M A I R E (Swiss)

- 1. Civil status: born in 1902 at Goneva, married, 3 children.
- 2. University degrees:

Degree in Economics (1925), then Doctorate in Economics, University of Geneva (1945): thesis on work relationships, called 'Au-Delà du Salariat, l'Organisation Sociale du Travail' (Beyond the Wage Earner, the Social Organization of Work) published in Geneva and Paris.

- 3. Languages: French (mother tongue), English, German, Italian and Spanish.
- 4. Activities in FAO:

Vice-Chairman of the Swiss National FAO Committee, and its principal delegate; he has represented Switzerland at all the Council and Conference Sessions in this capacity since 1947; since 1950 he has been Head of the Swiss Delegation to the Conference.

Within FAO, he has been appointed to the following offices by either the Council or Conference:

- in 1949: Chairman of the Preparatory European Regional Conference;
- in 1949: Chairman of Commission II of the Fifth Conference, Washington;
- in 1950: Chairman of the Committee of the Whole of the Special Session of the Conference, Washington;
- in 1952 and 1953: Member of the Committee on Financial Control (2 years);
- from 1954 to 1956: Chairman of the Committee on Financial Control (3 years);
- from 1952 to 1956: Member of the Co-ordinating Committee (now Program Committee) (5 years);
- from 1954 to 1957: Swiss delegate to the Council (4 years) and Vice-Chairman of the Council during the Twenty-Seventh Session.

5. Other inter-governmental activities

- From 1949, member of the Swiss delegation to the Committee on Agricultural Problems of the Economic Commission for Europe; he was elected Vice-Chairman in 1950 and Chairman in 1954, a post he still occupies.
- Member of the Swiss delegation to the European Conference on the Organization of Agricultural Markets (Paris 1952-1954); he took part in the work of the Preparatory Committee, then of the Intermediary Committee, and presided over a small group which after the Conference of Ministers of Agriculture in 1954 brought forward the

- Swiss delegate to the diplomatic conferences of Stress and Scheveningen in 1951 which introduced the International Cheese Convention on the use of place names and names of origin for cheeses.
- in 1942, appointed by the Swiss Government as an expert to the 'Commission permanente franco-suisse des zones franches' (Permanent Franco-Swiss Commission on Free Customs Zones).

6. Professional activities

- From 1925 to 1929, Dr. Mairo carried out many business re-organizations on behalf of the trust company 'Société Anonyme Fiduciairo Suisse' in Switzerland, France, Italy and Spain.
- In 1929, he took a post with the 'Fédération des Producteurs de Lait' (Federation of Milk Producers) of Geneva and became its Director-General in 1934; he also directs two associated societies, one of which is the 'Union Laitière, S.A.' (Dairy Farmers' Union, Ltd.).
- Since 1936, Dr. Maire has sat on the board of the 'Comité National de l'Union Centrale des Producteurs Suisses de Lait' (National Committée of the Central Swiss Milk Producers' Union) and since 1953 he has been their first Vice-Chairman (this organization directs the Swiss dairy industry in conjunction with Government services); he also sits on the 'Butyra' Council, a public company that regulates the supply and import of buttor, and on the boards of several important organizations of the dairy industry.
- The Government also appointed him to the Federal Commission of Experts that drafted the Agricultural Improvement Law of 3 October 1951; he was also called to serve with the Federal Commission of Experts that studied collaboration between employers and workers, as well as with the 'Commission Paritaire de Stabilisation des Prix et des Salaires' (Parity Commission on the Stabilization of Prices and Wages) formed by representatives of employers and workers having the task of stopping the rise in the cost of living.
- He has frequently represented his country at meetings of the International Federation of Agricultural Producers (IFAP), the European Confederation of Agriculture and the International Dairy Federation (IDF) with all of which he has very close connections.
- He still sits on the boards of many institutes and organizations, among which are: the Board of the Geneva Chamber of Commerce; the Swiss National Committee of the International Chamber of Commerce (which he represented at the meeting of the Committee for Full Employment of the International Chamber of Commerce); the 'Conseil de la Caisse Hypothécaire de Genève' (Board of the Mortgage Bank of Geneva) (a bank owned by the Geneva communes); the board of one of the leading Swiss life insurance companies at Zurich; and he is still Chairman of the Board of the trust company 'Société Fiduciaire Ofor' at Geneva.
- Finally, since 1956, he has been on the 'Comité de Patronage' (Patrons' Committee) of the 'Association Aide Suisse à des régions extracuropéennes' (Association for Swiss Aid to Extra-European Regions) at Zurich which gives technical assistance to various countries.
