Dear Mr Secretary-General,

I have the pleasure to inform you of the decision of the Government of Tunisia to submit the candidature of Mr Lassaad BEN OSMAN, Minister of Agriculture, for election to the post of Independent Chairman of the Council of the Food and Agriculture Organization of the United Nations to be held during the Twenty-third Session of the FAO Conference in November 1985.

I should like to draw to your attention the fact that the candidature submitted by Tunisia on behalf of the Near East Region received the support of the Council of the League of Arab States at its most recent session. In this connection, kindly see the attached copy of resolution 32 to that effect adopted at the said session.

I am also attaching herewith the curriculum vitae of Mr BEN OSMAN who at the beginning of his career worked at the Ministry of Agriculture as Ingénieur Directeur (Chief Engineer) with many responsibilities in the field of hydraulics and rural equipment. Subsequently he occupied high positions in the Tunisian Government where for the past 20 years he successively held the posts of Secretary of State for Agriculture (1967), Minister of Public Works and Housing, Minister of Equipment and currently Minister of Agriculture.

During his career Mr BEN OSMAN also fulfilled outstanding responsibilities at international and regional level as well as in the African and Arab world. In the course of his duties he represented Tunisia at many congresses and conferences including, among others, several sessions of the FAO Conference since 1967. He was also elected Vice-Chairman of the World Conference on Fisheries Management and Development held in Rome in July 1984.

I should therefore be obliged if you would kindly take note of Mr BEN OSMAN's candidature for the post of Independent Chairman of the Council of FAO and make the necessary arrangements.

Mr BEN OSMAN holds the Grand Cordon de la République (highest decoration of the Republic) and the Ordre de l'Indépendance (Order of Independence) awarded to him by President Habib Bourguiba, President of the Republic of Tunisia in recognition of his outstanding services to his country. He also holds a number of decorations from many foreign countries.
