### EXPERIENCE

Scarascia Mugnozza's main scientific experience lays on **genetics and breeding** of crops such as *durum wheat*, barley, sunflower, pea, globe artichoke, on **mutagenesis** of *Triticum durum*, *Pisum sativum*, and *Vicia faba*, and on collection, conservation and utilization of **biodiversity**, with special reference to the plant genetic resources of the Mediterranean Region.

After studies on spontaneous mutability in plants, through experimentally induced mutations Scarascia Mugnozza has investigated the **theoretical** (fertility of lines with structural and chromosomal rearrangements, dicentric chromosome transmission, effects of irradiation of plants at specific ontogenetic stages (gametophyte, zygote, etc.), cytogenetical and genetic effects of neutrons, gamma-rays, and chemical mutagens), **methodological** (selection techniques of mutant lines, selection methods in sexually reproducing and asexually propagated plants) and **applied** aspects of **mutagenesis and mutation breeding**. Some varieties of durum wheat and sunflower bred by Scarascia Mugnozza and co-workers are now grown in Italy and other Mediterranean Countries; some lines developed in his breeding programs are currently utilized, in Italy and abroad, as parental material in intra- and interspecific hybridization experiments and for breeding programmes in durum wheat and Triticale.

Scarascia Mugnozza worked also on the preservation of **germplasm** of species of relevant agricultural value such as *Triticum durum*, *Pisum sativum*, *Vicia faba*. On the basis of a Scarascia Mugnozza's proposal and project, the Italian National Research Council established, in 1969 in Bari, the Italian Institute of Germplasm.

As member of the **FAO-IBPGR (International Board for Plant Genetic Resources)**, he has promoted and raised funds from the Government of Italy: 1) for restructuring seed conservation facilities at both the International Institute for Tropical Agriculture (IITA), Ibadan, Nigeria, and the International Center for Tropical Agriculture (CIAT), Cali, Columbia, and 2) for constructing an entirely new Genetic Resources building at ICARDA, Aleppo, Syria, and a laboratory for N-fixing Bacteria Genetic Resources at the International Rice Research Institute (IRRI), Los Banos, The Philippines.

In more recent years, he has been devoting particular attention to the **genetical and breeding problems** of wheat seed quality; to the **protection of the agrosystem** through a **reduction of the application of agrochemicals** by means of new crop breeding strategies; to the use of **genetical biotechnologies**; and to the global monitoring of the natural resources as a contribution to **food security and rural development**.

As Chairman of the Italian National Institute of Nutrition, Scarascia Mugnozza has promoted studies and researches on some problems of the agrofood system and human nutrition in developing

countries, particularly in relation to the biological impact of energy stress on at risk and vulnerable categories of communities (India, Ethiopia, etc.). In 1986 Scarascia Mugnozza, at the occasion of the 40th anniversary of the FAO establishment, organized in Rome a "forum" on "sustainable food production and nutrition security" with the participation of scientists of different scientific areas, working in developed and developing countries.

Relevant has been his activity in the field of the **international scientific cooperation** for enhancing agricultural productivity in the less developed countries, and in strengthening the involvement of the Italian Government in bilateral and multilateral (FAO, CGIAR etc.) research and training programs for the developing world, in the perspective of the improvement of socio-economic conditions of those populations, as a pre-requisite for the solidarity among the human beings.

As member of the "Technical Advisory Committee" of the CGIAR, and consultant of the Italian Ministry of Foreign Affairs for the CGIAR programmes, Scarascia Mugnozza took part in the negotiations (1991-1993) for the approval by the Italian Parliament of the "Establishment Agreement" and the "Headquarters Agreement" of the "International Plant Genetic Resources Institute" (IPGRI).

In November 1995, at the opening ceremony of the 28th Intergovernmental FAO Conference Scarascia Mugnozza was invited to give the 19th McDougall Memorial Lecture on "The protection of biodiversity and use of genetic resources for food and agriculture: potential and perspectives".

In July 1996 in Madras, Scarascia Mugnozza and M.S. Swaminathan, President of the Indian Academy of Agricultural Sciences, with a financial support of the Italian Government, organised a **Science Academies Summit**, with the cosponsorship of the Third World Academy of Sciences. The Summit adopted the "Madras Declaration", an agenda for science and public policy based on the unique opportunities offered by sciences and technology for a global evergreen revolution. The "Madras Declaration" has been submitted to the world leaders assembling at the **World Food Summit**, convened by FAO in Rome in November 1996.

In August 1996, Scarascia Mugnozza and Swaminathan decided to launch an "Appeal to concerned scientists throughout the world, for the safe conservation and optimal utilization of biodiversity and genetic resources for food and agriculture, and the fair and equitable sharing of the benefits".

The motion, undersigned by almost 1000 scientists and experts belonging to 80 Countries, was presented to the "International FAO Commission on genetic resources for food and agriculture" and to the Governments at the FAO World Food Summit (Rome, 13-17 November 1996).



Scarascia Mugnozza is author (or co-author) of more than 300 scientific and technical papers.
