<b>Description of work</b>	The EWG should: (i) To determine if the <i>Guidelines on performance criteria of pesticide residues in food and feed</i> (CXG 90-2017) adequately cover mass spectrometry and if so, to propose revocation of the <i>Guidelines on the use of mass spectrometry for the identification, confirmation and quantitative determination of pesticide residues</i> (CXG 56-2005). (ii) If there are provisions from CXG 56-2005 that could be relevant but not included in CXG 90-2017, to look into the feasibility to merge the two documents, and: (a) if appropriate to present a proposal for new work, and (b) if possible, to present an outline of the merged guidelines for consideration at CCPR53.
