The Codex Committee on Spices and Culinary Herbs, at its 3<sup>rd</sup> Session (CCSCH3 2017), agreed to recommend to CAC to approve the proposed strategy for developing horizontal group standards which would enable the Committee to increase its outputs as well as complete its work in a defined time. In undertaking this work, this EWG (dried garlic) will closely collaborate with the EWG on "dehydrated or dried ginger" to develop the overall group standard for *"Dried Roots, Rhizomes and Bulbs"*.
