EIFAAC promotes the long-term sustainable development, utilization, conservation, restoration and responsible management of European inland fisheries and aquaculture, consistent with the objectives and principles of the FAO Code of Conduct for Responsible Fisheries and other relevant international instruments.

Most countries in Europe are member of this statutory body of FAO. Currently EIFAAC has 34 countries and the European Union as member.

EIFAAC was established in 1957 and has held 30 sessions since its establishment. The sessions are organized every 2 years. The 31st session of EIFAAC is scheduled to take place in Killarney, Ireland on 22-24 June 2022.

The <u>costs</u> involved in EIFAAC membership are low, and involve mainly the costs of participation of delegates from your country in the sessions and expert meetings. Inland fisheries and aquaculture experts from your country who participate in EIFAAC projects will be requested to contribute their time.

If [name of country] would like to become member of EIFAAC, you should inform the FAO Director General, Dr. QU Dongyu of your wish to become member. A formal letter from the minister to the FAO Director General would be sufficient.
