APPLICATION FOR TRANSFER OF CERTIFICATE FOR APPROVED LIVING MODIFIED PRODUCTS FOR SUPPLY OR OFFER TO SUPPLY FOR SALE OR PLACING IN THE MARKET

The National Biosafety Board (NBB) on the 14 December 2018 reviewed the request from Du Pont (M) Sdn. Bhd. to transfer the certificate of approval to Du Pont Production Agriscience (M) Sdn. Bhd. This request was made in writing to the NBB in compliance to Regulations 13 and 14 of the Biosafety (Approval and Notification) Regulations 2010. The relevant documentations to support the basis of this request was reviewed by the NBB.

The merger between Dow and Du Pont has been completed. The merger resulted in all assets, registration and contracts under the name of Du Pont (M) Sdn. Bhd. to be transferred to Du Pont Production Agriscience (Malaysia) Sdn. Bhd. This includes ownership of products of Living Modified Organisms (LMO) that have been approved by the NBB.

NBB has previously approved the following LMO products to Du Pont (M) Sdn. Bhd. as the approved person:

The NBB approved the request to transfer the certificate of approval from Du Pont (M) Sdn. Bhd. to Du Pont Production Agriscience (Malaysia) Sdn. Bhd. for these LMO products. A new certificate of approval has been issued for these 5 LMO products with Du Pont Production Agriscience (Malaysia) Sdn. Bhd. as the approved person.

The approved LMO product is only for the purpose of food, feed and processing (FFP) and is not to be used as planting material. All terms and conditions imposed for the approval of each of the LMO products remain the same and Du Pont Production Agriscience (Malaysia) Sdn. Bhd. is responsible for compliance of these terms and conditions.

Reference to the specific terms and conditions of each LMO product may be found in Appendix 1 of the original NBB Decision Documents of the approval of these products.

Du Pont Production Agriscience (Malaysia) Sdn. Bhd. is required to co-operate with the relevant Government agencies on all matters related to monitoring of these approved LMO products.
