



## **THE WORKPLAN AND MEETING SCHEDULE OF THE EXECUTIVE COMMITTEE OF THE ECA FOR THE YEARS 2022-2023**

### **Introduction**

The Executive Committee of the ECA (the ExCom) endorsed its work plan and meeting schedule for the biennium 2022-2023 at the 39/1 meeting on 23 February 2022.

During the 39/3 meeting, the ExCom requested that an item “Impact of the war in Ukraine on food security and related matters” be added to the agendas of upcoming ExCom meetings. The Secretariat of the ECA added the item to the list of tasks and to the scopes of the agendas of the ExCom meetings, starting from June 2022.

The revised draft list of tasks of the ExCom and their respective timeframes in the years 2022-2023 is presented in Annex 1.

The revised schedule of meetings of the ExCom for the years 2022-2023, until the Forty-third Session of the ECA, is presented in Annex 2. The schedule assumes that the Forty-third Session of the ECA will be held as tentatively planned (26-28 September 2023).

The ExCom is invited to:

- note the updated schedule and scopes of the ExCom meetings for the years 2022-2023, as presented in Annex 2
