Legal frame and laboratory capacity

- · Legislation in line with EU legislation
 - Law on Veterinary Health in accordance with the Council Directive 92/119/EC
 - Programme for control and eradication of Bluetongue disease (OJ of RM 82/07)
 - Council Directive 2000/75/EC (as last amended)
 - Commission Regulation 1266/2007/EC (as last amended)
 - Other
- Notifiable disease (Book of Rules for control and eradication of compulsory notifiable diseases in accordance with the Council Directive 82/894/EC)

Lumpy skin disease and bluetongue training of trainers in FYR of Macedonia

Laboratory capacity

- Appropriate laboratory capacity
 - ELISA serology,
 - RT-PCR generic for BTV serotypes,
 - RT-PCR for BTV 1, 2, 4, 8, 9 and 16
 - Virus isolation in embryonated eggs and cell culture

Case definition


- Suspect case animals that exhibit clinical sings of the disease
- Confirmed case animals that reacted positive laboratory results and animals on contact holdings that exhibit clear sings of disease




















Measures implemented - Restrictive measure apply according program for control and eradication of Bluetongue disease (OJ of RM 82/07) - Welfare of animals, - Cleaning, disinfection and dezinsection, - Use of repellents, - Treatment of manure, - Treatment of other organic waste etc. - Decisions, instructions - Posters, brochures, informative materials




