

#### ECA EXECUTIVE COMITTEE WORKPLAN AND MEETING SCHEDULE FOR 2019-2021

#### Introduction

The ECA Executive Committee (ExCom) is the operational body of the European Commission on Agriculture (ECA). It meets 3-4 times a year, either virtually or with physical presence.

### Responsibilities of the ExCom

The ExCom is responsible for the management of the ECA and the execution of the recommendations and decisions of the ECA during the intersession period.

The ExCom is governed by the respective articles of the Rules of Procedure of ECA.

In addition, the ExCom is entrusted as the only intersession body in the Region to support the preparation of the Sessions of the European Commission on Agriculture<sup>1</sup>. This implies that the ExCom will provide suggestions and feedback for the topics of the Regional Conference for Europe. Other tasks of the ExCom include the preparation of the Informal Consultations (IC) in the year of the ECA Session, as well as the review of the work programme of the Regional Office for Europe and Central Asia (REU) and recommendations on its implementation.

In general, the ExCom and its members are requested to:

- provide inputs for discussion and consideration within the mandate of the ECA
- suggest actions of the ExCom to be undertaken within the mandate of the ECA.

In relation to this document the ExCom is invited to:

- review and endorse the list of tasks of the ExCom for 2019-2021 and their respective timeframes
- review and endorse the schedule and scopes of the ExCom meetings for 2019-2021
- note that more tasks may be added or the schedule and scopes of the meetings may be modified according to current needs.

The list of tasks of the ExCom and their respective timeframes for 2019-2021 are presented in Annex 1.

The proposed schedule of meetings of the ExCom for the current term is presented in Annex 2.
