STATE STATISTICS ON CUSTOMS



Clause 1, Article 97, Law on Customs 2014: Statistics on exported and imported goods is the process of collecting, processing, summarizing, analyzing, popularizing and archiving statistical information on exported and imported goods carried out by the General Department of Customs



DEFINITION – LEGAL BASIS

Regulations on statistics on exported and imported goods as promulgated in the Law on Customs 2014

Article 97: Statistics on exported and imported goods

1. Statistics on exported and imported goods is the process of collecting, processing, summarizing, analyzing, forecasting, reporting, popularizing and archiving statistical information on exported and imported goods carried out by the General Department of Customs.

2. Statistical information on exported and imported goods is a product of statistical activity, including statistical data on exported and imported goods and analyses of these statistics.

3. The General Department of Customs shall publish publications on statistics on exported and imported goods.

Article 98. Statistical reports on exported and imported goods


The General Department of Customs shall send to the Government and Ministry of Finance monthly statistical reports on exported and imported goods according to prescribed forms and reports on analysis and assessment of the exportation and importation of goods



ROLES OF STATISTICS ON EXPORTED AND IMPORTED GOODS



Export and import value of Viet Nam from 1995 to 2018



Scope of statistics



Leave (export) and enter (import) the customs territory of Viet Nam

Decrease or increase material resources of Viet Nam



Temporarily enter or leave the customs territory of Viet Nam

Do not increase or decrease material resources of Viet Nam



Goods taken into account in statistics

Goods traded and exchanged by Vietnamese organizations, individuals with foreign organizations, individuals, including:

- a) Goods exported and imported under goods purchase and sale contracts;
- b) Goods exported and imported in the form of importing raw materials to produce goods for export;
- c) Goods exported and imported to perform processing contracts concluded with foreign countries;
- d) Goods exported and imported to implement investment projects;
- e) Goods traded in the form of temporary import for re-export, temporary export for re-import (excluding goods temporarily imported for re-export or temporarily exported for re-import within a certain period of time);



Statistical value of exported and imported goods

- Statistical value of exported and imported goods is the value developed by organizations, individuals performing statistical work for the purposes of statistical summary and report.
- General principle:
 - ❖ For imported goods: CIF
 - ❖ For exported goods: FOB

Statistical value of exported and imported goods (cont.)

Determination of value for each specific case

- For goods which are liable to duty
- For goods which are not liable to duty, are duty-free or exempted from duty:
 - ❖ For imported goods: according to selling price at the first border gate of importation (CIF, DAF, DAP).
 - ❖ For exported goods: according to actual selling price at the border gate of exportation (FOB, DAF, DAP).
 - ❖ In case that statistical value of goods can not be determined, it shall be converted into the value based on FOB conditions (for exported goods) or based on CIF conditions (for imported goods)

Trading partner countries in statistics

- **For exported goods:** country or territory of final destination determined at the time of exportation, not including country or territory through which goods transit
- **For imported goods:** Country or territory of origin

Units of calculation, currencies and exchange rates used in statistics

Units of calculation in statistics on exported and imported goods

- According to regulations applicable to customs declaration forms
- When converting into other units of calculation of quantities for statistical purposes: based on gross weight, net weigh, average unit price and other items on the declaration forms and relevant documents



Units of calculation, currencies and exchange rates used in statistics

Currencies and exchange rates used in statistics on exported and imported goods


- Viet Nam Dong and US Dollar
- Other foreign currencies shall be converted into VND and USD based on average transaction exchange rate on the inter-bank foreign currency market announced by the State Bank of Viet Nam at the time of declaration registration




