MEMBERSHIP OF THE WFP EXECUTIVE BOARD

- 1. In accordance with Resolution 6/99 adopted by the 30th Session of the FAO Conference on 13 November 1999, the Council is required to elect six members of the WFP Executive Board for a term of office of three years from among FAO Member Nations.
- 2. For purposes of election to the Board, FAO Member Nations are divided into five separate lists (A, B, C, D and E) as shown on the FAO Council Web page under "Other Documents": http://www.fao.org/unfao/bodies/council/cl138/Index en.htm
- 3. The Council will therefore be required to elect six members for a term of office expiring on 31 December 2012 to replace the ones whose terms end on 31 December 2009, i.e. Zambia (List A); Pakistan and Philippines (List B); Peru (List C); Netherlands and United States of America (List D)
- 4. Outgoing members are eligible for re-election.
- 5. A nomination form is given in the <u>Appendix</u>. The deadline for submission of nominations to the Secretary-General of the Conference and Council is <u>12.00 hours on Friday 20 November</u> 2009.
