# SIDE EVENT:

The added value of decentralized approach for food security: the action plan of regions and federated states

### The commitment of a Global Assembly of Regions to tackle food insecurity

FOGAR has been created in Cape Town in August 2007 on the basis of the "Declaration of the Regions on their participation to the governance of Globalization" adopted in Marseille in March 2007. Through its 17 networks of Regions from all the continents, it gathers 900 Regions (that's to say the level of public governments immediately under the central one of the States recognized by the UN system). Since July 2010, FOGAR is

also opened to membership of individual Regions and Federated States following the decisions taken during its General Assembly in Ecuador, hosted by M. Rafael Correa, President of the Republic of Ecuador.

Two years ago, willing to bring its own answers to food riots, the Executive Committee of FOGAR, meeting in Tangiers, decided to launch a cycle of actions on Food Security and Nutrition. This initiative was encouraged by M. Nabarro, Special Representative of the Secretary General of UN, the European Commission, the Spanish and French Cooperation, UNDP and, particularly, by the General Director of FAO, M. Diouf. In this way a MOU between FAO and FOGAR has been signed in March 2009. Answering to an invitation of the President of the Republic of Senegal, M. Wade, to host it, FOGAR organized on 18 and 19 January 2010 in Dakar a Summit of the world's Regions for Food Security, gathering 850 participants from the different continents (www.regionsfoodsummit.org).

On the basis of the sessions and conclusions of these two days, members of FOGAR have created a Core Group of 20 Regions from the south and the north to propose and implement a multi annual action plan in the 9 areas where a more decentralized approach of food security has been identified as an added value. It promotes a better inclusion of regions into Strategic Frameworks of International Organizations and National Policies.
